Summary: On February 24, 2009, the Board of County Commissioners (BCC) adopted Resolution No. 2009-0319 which re-established NAMAC with seven at-large members. Pursuant to Resolution No. 2009-0319 the composition of NAMAC is as follows: one (1) member with experience in the management of natural areas, one (1) biological scientist, one (1) professional educator with knowledge of South Florida ecosystems, one (1) representative of a local municipal government public recreation program, one (1) member of the Palm Beach County Parks and Recreation Department staff, two (2) citizens having an interest in preservation and conservation of natural areas. A memorandum from Environmental Resources Management was sent to the BCC on August 13, 2012 advising them of the need to appoint or reappoint members to fill the above seats. Ms. Kristi Moyer expressed her willingness to assume the duties of Seat 5 for another term. Ms. Cindy Papadoyianis expressed her willingness to assume the duties of Seat 6 for another term; only one person may be appointed for Seat 6. All of the nominees meet the necessary requirements. <u>Countywide (SF)</u>

Background and Justification: The BCC determined that it is in the best interest of the citizens of Palm Beach County that NAMAC be formed to evaluate and comment on staff-developed management plans with a specific focus on public uses of the site and to make recommendations to staff on possible changes with final approval by the BCC. Pending approval of the attached request for appointments/reappointments, NAMAC will be comprised of five White men (two residing in the northern portion of PBC and three residing in the central portion of PBC) and two White women (one residing in the central portion of PBC and one residing in the southern portion of PBC); or five White men (two residing in the northern portion of PBC and three portion of PBC and three residing in the central portion of PBC) in the central portion of PBC, one White woman (residing in the central portion of PBC) and one Hispanic woman (residing in the northern portion of PBC).

Summary of Qualifications

Seat 3 - "Professional Educator with Knowledge of South Florida Ecosystems" - One (1) Applicant

Ms. Kristi Moyer is the Facilities and Land Manager at Pine Jog Environmental/FAU Preserve (Pine Jog). She has a Master's degree in Curriculum and Instruction, with an emphasis in environmental education. Ms. Moyer has the responsibility of creating and implementing all aspects of the Pine Jog land management plan, including a prescribed burn plan and several environmental restoration projects. She has designed and implemented workshops, written curriculum, and created and taught school programs for the school yard and natural areas.

<u>Seat 5 - "Member of the Palm Beach County Parks and Recreation Department Staff" – One (1)</u> <u>Applicant</u>

Mr. Eric Call is the Director of Palm Beach County's Parks and Recreation Department (Parks Department). He has a Bachelor of Science in Recreation. Mr. Call is responsible for directing and coordinating all aspects of the Parks Department including, but not limited to, the administrative oversight of a \$60 million general operating budget, review and coordination of recreation programs, long-range planning and park design, and general grounds and facility maintenance. Mr. Call has served on NAMAC since November 2010.

<u>Seat 6 – "Citizen Having an Interest in Preservation and Conservation of Natural Areas" –</u> <u>Two (2) Applicants – Select one</u>

Ms. Cindy King Papadoyianis is the Director of Development for the US Green Building Council South Florida Chapter. As the PTA Green Chair at Morikami Park Elementary School, she enlisted the aid of 150 students, parents, teachers and community members to create a 2-acre wetland, pine flatwoods and oak hammock habitat and "outdoor natural area classroom" adjacent to the school. 



The terms for three positions on Palm Beach County's Natural Areas Management Advisory Committee (NAMAC) will expire on October 31, 2012. Mr. Steve Bass, Seat 3, currently serves as a "professional educator with knowledge of South Florida ecosystems," Mr. Eric Call, Seat 5, currently serves as a "member of the Palm Beach County Parks and Recreation Department staff," and Ms. Evelyn Parkes-Brier, Seat 6, currently serves as a "citizen having an interest in preservation and conservation of natural areas." The resolution establishing NAMAC states that the composition of the committee shall be as follows: one (1) member with experience in the management of natural areas; one (1) biological scientist; one (1) professional educator with knowledge of South Florida ecosystems; one (1) representative of a local municipal government parks and recreation program; one (1) member of the Palm Beach County Parks and Recreation Department staff; and two (2) citizens having an interest in preservation and conservation of natural areas.

Mr. Bass has indicated that he will retire from NAMAC when his term expires. Mr. Call and Ms. Parkes-Brier have both indicated a willingness to continue serving on NAMAC, if appointed by the Board. RESOLUTION NO. R-2009- 0319

COUNTY RESOLUTION THE BOARD OF OF COMMISSIONERS PALM BEACH COUNTY. OF AREAS · CREATING THE NATURAL FLORIDA, MANAGEMENT ADVISORY COMMITTEE; PROVIDING FOR MEMBERSHIP; PROVIDING FOR TERM AND MEETINGS **REMOVAL;** PROVIDING FOR AND **ORGANIZATION;** PROVIDING FOR DUTIES AND FUNCTIONS; PROVIDING THAT COMMITTEE ACTION IS ADVISORY ONLY; PROVIDING FOR ASSISTANCE TO THE COMMITTEE; PROVIDING FOR RATIFICATION; **PROVIDING FOR REPEAL OF RESOLUTIONS 94-1051,** 95-1455, 99-1188, AND 2003-0713.

WHEREAS, the Board of County Commissioners of Palm Beach County (the "Board") created the Natural Areas Management Advisory Committee by adoption of Resolution 94-1051, on August 16, 1994, to review and comment on management plans developed by staff for environmentally sensitive lands purchased or leased by the County and to hold public hearings on these plans prior to final adoption by the Board; and

WHEREAS, Resolution 94-1051 was amended by Resolutions 95-1455, 99-1188 and 2003-0713, and over the course of time certain portions of the Resolution and amendments have become obsolete; and

WHEREAS, the Board wishes to repeal the existing Resolutions pertaining to the Natural Areas Management Advisory Committee in order to remove obsolete provisions and to consolidate all necessary provisions into one Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

Section 1. <u>Creation</u>. Upon adoption of this Resolution by the Board, there is created and established a committee to be known as the Palm Beach County Natural Areas Management Advisory Committee (the "Advisory Committee").

Section 2. <u>Purpose</u>. The purpose of the Advisory Committee is to review and comment on management plans developed by staff for natural areas and conservation lands managed by the Palm Beach County Department of Environmental Resources Management ("ERM"), with a specific focus on proposed public uses of these sites, and to make recommendations to staff on possible changes to each plan prior to making a recommendation to the Board on approval of the plan.

Section 3. Membership.

A. The Advisory Committee shall have seven (7) members who shall be appointed at large by the Board according to the provisions set forth herein. The composition of the Committee shall be as follows:

- 1. One (1) member with experience in the management of natural areas.
- 2. One (1) biological scientist.
- One (1) professional educator with knowledge of South Florida ecosystems.
- 4. One (1) representative of a local municipal government parks and recreation program.
- One (1) member of the Palm Beach County Parks and Recreation Department staff.
- Two (2) citizens having an interest in preservation and conservation of natural areas.

B. Appointment of individuals to the Advisory Committee.

1. The Board, acting as a whole, shall appoint seven (7) individuals to fulfill the requirements of subparagraphs A.1-6 of this section.

2. The Board shall make its appointments from a list of nominees submitted by Board members or by ERM, which shall solicit nominees in order to fulfill the requirements of subparagraph A.1-6 of this section.

3. All members of the Advisory Committee except the citizen representatives shall have expertise in biology/ecology, conservation of natural resources, environmental education, environmental land management, or public recreation. Each nominee, except nominees for a citizen advisory position, shall submit to ERM written evidence of his or her expertise in any of the above.

C. All appointments except for a vacancy shall be for a term of three (3) years. A member appointed to fill the remaining term of a vacancy shall serve until the expiration of the unfulfilled term. No member shall be reappointed without approval by the Board at one of its regular meetings.

Section 4. Conditions of Appointment.

A. There shall be no limit on the number of terms that an individual may serve.

B. County employees shall not be appointed to the Advisory Committee, except that an employee of the School District of Palm Beach County may be appointed as a representative of the education community, as specified in subparagraph A.3. of Section 3 of this Resolution, and that an employee of the Palm Beach County Department of Parks and Recreation shall serve on the Advisory Committee, as specified in subparagraph A.5 of Section 3 of this Resolution.

C. An Advisory Committee member who is an employee of a local government shall not represent specific interests of the local government on Advisory Committee issues.

Section 5. Meetings and Organization.

A. The Advisory Committee shall establish a regular time and place to hold business meetings. Reasonable public notice of all Advisory Committee business meetings, field trips and public hearings shall be provided, and all such business meetings, field trips and public hearings shall be open to the public at all times and shall allow public comment.

B. A quorum must be present for the conduct of Advisory Committee business meetings. A majority of the members appointed shall constitute a quorum. All business meetings shall be governed by Robert's Rules of Order.

C. The Advisory Committee shall adopt any rules of organization and procedures that may be required. The Advisory Committee may elect a chairperson and vice chairperson, may establish subcommittees for specific subjects or tasks, and may invite participation in a subcommittee by nonmembers in order to obtain input from other sectors of the public interested in the management of natural areas and the duties of the Advisory Committee.

Section 6. <u>Duties and Functions</u>. The Advisory Committee shall have the following duties and functions:

A. To review and comment on initial and revised management plans developed by staff for natural areas and conservation lands managed by ERM, in accordance with the requirements of the Palm Beach County Natural Areas Ordinance (No. 94-13), as may be amended from time to time. B. To hold a public hearing on each management plan, as required, to solicit input from the public.

C. To consider oral and written public comments at hearings and at Advisory Committee business meetings.

D. To make a recommendation to the Board regarding the approval of each management plan reviewed by the Advisory Committee.

E. To review and comment on conceptual site plans prepared by staff as part of grant applications for funding for acquisition and/or management of natural areas.

F. To review and comment on staff-proposed interim changes to management plans.

G. To review the results of ongoing monitoring of natural areas to determine whether management goals are being met.

H. To make recommendations to staff regarding policies related to the management of the natural areas.

I. To periodically review management plans for possible modification.

Section 7. Assistance to the Committee. The Advisory Committee may call upon any department or other agency of the County, regional, state, federal or local governments for information or advice in the performance of its work. Staff from ERM shall provide administrative support to the Advisory Committee. The County Attorney's Office shall act as legal counsel to the Advisory Committee at all its meetings and shall provide such legal advice and assistance as may be requested by the Advisory Committee.

Section 8. <u>Committee Action Advisory Only</u>. The actions, decisions and recommendations of the Advisory Committee are advisory only and shall not be binding on the Board or County staff.

Section 9. <u>Ratification</u>. Notwithstanding anything contained herein, this Resolution also hereby acknowledges, ratifies, and confirms all actions of the Advisory Committee known as the Natural Areas Management Advisory Committee as was previously approved and organized by the Board of County Commissioners prior to the formal adoption of this Resolution. This Resolution hereby acknowledges, ratifies, and confirms the appointment of each currentlyserving member of the Advisory Committee appointed pursuant to Resolution 94-1051, as amended, and each such member shall continue to serve on the Advisory Committee until such member's three (3)-year term under the previously existing Resolution 94-1051, as amended, expires.

Section 10. <u>Severability</u>. If any section, sentence, clause, phrase, or word of this Resolution is held to be invalid or unconstitutional by any court of competent jurisdiction, then said holdings shall in no way affect the validity of the remaining portions of the Resolution.

Section 11. Repeal of Resolutions 94-1051, 95-1455, 99-1188 and 2003-0713.

This Resolution expressly repeals and supersedes Palm Beach County Resolutions 94-1051, 95-1455, 99-1188 and 2003-0713, except to the extent that certain actions taken thereunder are ratified as provided herein.

The foregoing Resolution was offered by Commissioner Marcus , who moved its adoption. The motion was seconded by Commissioner Aaronson , and upon being put to a vote, the vote was as follows:
