It is anticipated that the County will re-bid the uniformed security guard services contract in the next few months. The County has encumbered \$25,420 (\$726/month) during the previous thirty-five (35) months of the current thirty-six (36) month term contract. Due to the death of one (1) of the two (2) existing special masters, Purchasing issued RFS No. 800097RR in an effort to solicit the service of additional special masters. The solicitation resulted in the County contracting with one (1) additional special master. Purchasing is requesting a seven (7) month extension of the contract in order for both special master contracts to expire at the same time. This term contract has two (2) renewal periods remaining. Awardee is located outside Palm Beach County in the City of Fort Lauderdale. This contract was established by a competitive RFS process that considered SBE participation in the evaluation. No certified SBE participation was offered by the recommended Awardee.
