I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to:

- A) Adopt a Resolution approving Amendment Number Five to the Transportation Regional Incentive Program (TRIP) Agreement R2008-0939 with the State of Florida Department of Transportation (FDOT), approved on June 3, 2008, to reduce the FDOT TRIP funding and increase the FDOT non-TRIP funding for construction and construction engineering inspection of the C-51 Bridge at the SR7/SR80 Intersection project (Project) and extend the expiration date to June 30, 2013; and
- **B)** Approve a Budget Amendment of \$2,051,646 in the Road Impact Fee Fund Zone 3 to recognize a TRIP agreement with FDOT and appropriate it to the Project.

SUMMARY: Approval of Amendment Number Five to the Agreement will reduce the FDOT TRIP funding and increase the FDOT non-TRIP funding to match the awarded construction contract amount. It will also extend the expiration date of the TRIP agreement to June 30, 2013. A Palm Beach County (County) match of \$708,613 is required and represents the County's share of TRIP funding.

District 6 (MRE)

Background and Justification: On June 3, 2008, the Board of County Commissioners (Board) approved a TRIP Agreement R2008-0939 with FDOT. The Agreement was approved by FDOT on June 25, 2008. This Agreement provides the County with financial assistance for construction and construction engineering inspection of the Project (FDOT TRIP 50% funding of \$926,000). Amendment Number One R2009-0625 was approved by the Board on April 21, 2009, to fully fund (FDOT non-TRIP 100% funding of \$900,000) the addition of a northbound right turn lane and modifications to the eastbound and westbound SR 80 exits from single lanes to dual lanes. Amendments Number Two, Three, and Four extended the expiration dates. Amendment Number Five will adjust the FDOT TRIP funding to \$708,612.85 and increase the FDOT non-TRIP funding by \$443,033.03 to match the awarded construction contract amount and extend the expiration date to June 30, 2013. In summary, this \$2,760,258.73 Project will be constructed with \$708,612.85 of County funds and \$2,051,645.88 of FDOT funds.



STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION AND PALM BEACH COUNTY TRANSPORTATION REGIONAL INCENTIVE PROGRAM AGREEMENT AMENDMENT NUMBER FIVE

THIS AMENDMENT, made and entered into this _____ day of _____, 20_____, by and between the State of Florida Department of Transportation, hereinafter called the DEPARTMENT, and Palm Beach County, located at 2300 North Jog Road, West Palm Beach, Florida 33411, hereinafter called the COUNTY.

WITNESSETH

WHEREAS, on June 25, 2008 the parties entered into a Transportation Regional Incentive Program (TRIP) Agreement, hereinafter referred to as the Agreement, wherein the COUNTY agreed to provide certain improvements in connection with Financial Management (FM) No. 422768-1-58-01 for the Widening, Construction, and Construction Engineering Inspection (CEI) Services of C-51 Bridge at the SR7/SR80/Southern Blvd. Intersection, hereinafter referred to as the Project; and

WHEREAS, the parties amended the Agreement on May 12, 2009 (AMENDMENT NUMBER ONE), May 12, 2010 (AMENDMENT NUMBER TWO), December 30, 2010 (AMENDMENT NUMBER THREE); and June 3, 2011 (AMENDMENT NUMBER FOUR); and

WHEREAS, the parties desire to further amend the Agreement; and

WHEREAS, the parties hereto mutually agree that this Amendment is in their best interest;

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations herein, the parties agree to amend that certain Transportation Regional Incentive Program Agreement dated June 25, 2008, Amendment Number One, and Amendment Number Four as follows:

- 1. The recitals set forth above are true and correct and are deemed incorporated herein.
- 2. This Amendment reduces the DEPARTMENT's share of TRIP funding originally in the amount of NINE HUNDRED TWENTY SIX THOUSAND DOLLARS (\$926,000.00) to be paid to the COUNTY. The reason for the reduction in funding is due to the final accepted bid being a sum less than the original estimated amount. As a result, the DEPARTMENT's and the COUNTY's share of TRIP funding is reduced by TWO HUNDRED SEVENTEEN THOUSAND THREE HUNDRED EIGHTY SEVEN DOLLARS AND FIFTEEN CENTS (\$217,387.15), which will make the total DEPARTMENT's share of TRIP funding SEVEN HUNDRED EIGHT THOUSAND SIX HUNDRED TWELVE DOLLARS AND EIGHTY

FIVE CENTS (\$708,612.85) for all services required to complete the Project. The COUNTY's share of TRIP funding in the amount of SEVEN HUNDRED EIGHT THOUSAND SIX HUNDRED TWELVE DOLLARS AND EIGHTY FIVE CENTS (\$708,612.85) is the minimum contribution from the COUNTY and does not include any additional costs that are the sole responsibility of the COUNTY.

3. The Agreement and Amendment Number One are amended to provide for an increased payment by the DEPARTMENT in the amount of FOUR HUNDRED FORTY THREE THOUSAND THIRTY THREE DOLLARS AND THREE CENTS (\$443,033.03), thus making the total DEPARTMENT share of state funding ONE MILLION THREE HUNDRED FORTY THREE THOUSAND THIRTY THREE DOLLARS AND THREE CENTS (\$1,343,033.03).

In the event the costs of the Project exceeds the DEPARTMENT's share of ONE MILLION THREE HUNDRED FORTY THREE THOUSAND THIRTY THREE DOLLARS AND THREE CENTS (\$1,343,033.03), any additional cost shall be the sole responsibility of the COUNTY.

i. All costs charged to the Project shall be supported by properly executed payrolls, time records, invoices, contracts, and/or vouchers evidencing in detail the nature and propriety of the charges. The COUNTY will be reimbursed only for actual expenses incurred during the Agreement time period that is directly related to the Project.

Except as otherwise set forth herein, this AGREEMENT shall continue in effect and be binding to both the COUNTY and the DEPARTMENT until the Project is completed as evidenced by the written acceptance of the DEPARTMENT or June 30, 2013, whichever occurs first.

All provisions, covenants, terms and conditions of the AGREEMENT between the parties theretofore entered into on June 25, 2008 and amended on May 12, 2009, May 12, 2010, December 30, 2010, and June 3, 2011, respectively, as originally set forth therein, which are not hereby expressly amended or modified and not in conflict with the terms hereof, are hereby ratified and confirmed and shall remain the same and be unaffected by these presents.
