I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: a notice of exercise of the third option to extend the term of the Concessionaire Service Agreement (R2007-2256) with Dania Pier Management Corp., for the continued use of the concession building at the Juno Beach pier for \$54,749.39/year.

Summary: Since January 1, 2008, Dania Pier Management Corp. (DPM) has operated under the current Concessionaire Service Agreement for the use of the concession building at the Juno Beach pier. DPM now wishes to exercise the third of three (3) one (1) year extension options for the period of January 1, 2013, to December 31, 2013. The Annual Rent will be increased by four percent (4%) from \$52,643.64 (\$4,386.97/month) to \$54,749.39 (\$4,562.45/month) effective January 1, 2013. The Parks & Recreation Department is satisfied with DPM's performance. The Board has no discretionary authority to deny the exercise of the option; however, the County may terminate this Agreement upon ninety (90) days written notice to DPM. (PREM) District 1 (HJF)

Background and Justification: The Agreement was approved on December 18, 2007 (R2007-2256). The first option was exercised on December 7, 2010 (R2010-2005). The second option was exercised on December 6, 2011 (R2011-1933). Exercise of this third option will extend the term through December 31, 2013. State Statutes do not require a Disclosure of Beneficial Interest to be obtained when the County leases property to a tenant. Since the Statute does not require the Disclosure and as this is an exercise of an option to extend a previously approved agreement for which a Disclosure was obtained, Staff did not request a new Disclosure. Donald V. Streeter is the President of DPM and owns 100% of DPM.


