I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Budget Transfer of \$11,408 in Park Improvement Fund from the Payment in Lieu of Recreation reserve to Green Cay Nature Center Improvements.

Summary: This budget transfer establishes funding for the Green Cay Nature Center Improvements project from reserves generated pursuant to the County's Unified Land Development Code (ULDC) Article 5, Parks and Recreation – Rules and Recreation Standards. Article 5 revenues originate from cash-outs from residential developments that are unable to provide homeowners onsite recreation areas. Revenues from this fund are to be used for the purpose of acquiring and/or developing land necessary to meet the need for neighborhood or community type recreational facilities created by the development. This funding will be used for LED lighting improvements/upgrades to the exhibit areas. Funding for this project is from the \$123,379.20 Payment In Lieu of Recreation payment received for the Aspen Square development. The balance of \$111,971.20 will remain after this expenditure. This project meets the requirements of ULDC Article 5. District 5 (AH)

Background and Justification: The County's ULDC Article 5.D.2.B requires that all proposed residential development shall make adequate provisions for recreation areas to accommodate the neighborhood and community park level recreational needs of the residents of the development. Article 5.D.2.B.5 allows, at the option of the Park and Recreation Department, the developer to contribute the dollar value of the total recreational area requirement at the time the first plat is submitted for recording. All such funds collected shall be held in a non-lapsing Park and Recreation Trust Fund for the acquisition and improvement of community or neighborhood parks according to the provisions of Article 5.D.2.B.6. Article 5.D.2.B.6 requires that monies deposited by a developer pursuant to this Chapter shall be expended to acquire and/or develop land for park purposes not farther than five miles from the perimeter of the development.





