I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 4 to Contract with Horizon Air Conditioning, Inc. (R2010-0067) to implement the third renewal of the annual Heating Ventilation Air Conditioning (HVAC) contract with a maximum value of \$2,000,000.

Summary: Amendment No. 4 is a renewal to the annual HVAC contract which was awarded to Horizon Air Conditioning, Inc. The annual HVAC contract is an indefinite-quantity contract and this renewal has a maximum value of \$2,000,000. The capacity is shared and work orders are awarded based on competitive quotes/bids issued to all six (6) participating contractors. The renewal term is for twelve (12) months or until \$2,000,000 in work orders are issued in this term. Staff is bringing forward the amendment at this time based on expiration of the term. All terms of the original contract remain in effect. This is the third of four extensions allowed by the contract. The goal for Small Business Enterprise (SBE) participation is 15% and will be tracked cumulatively for each work order issued. This is a bond waiver contract. Horizon Air Conditioning, Inc. had \$15,700 in work orders under this contract during the last term and their SBE participation for work orders issued to date is 69.60%. Horizon Air Conditioning, Inc. is a Palm Beach County company and a certified SBE contractor. (FD&O Admin) Countywide (JM)

Background and Justification: Amendment No. 4 is the third renewal to the Annual Contract – HVAC which was awarded to Horizon Air Conditioning, Inc on January 12, 2010. The contractor will continue to perform as an annual HVAC contractor for installation, repair, and/or replacement of HVAC systems on an “as-needed” basis for projects typically under \$100,000 each. The annual HVAC contract is an indefinite-quantity contract and this renewal has a maximum value of \$2,000,000 among the pool of annual HVAC contractors. The renewal term is for twelve (12) months or until the renewal limit of \$2,000,000 is reached.

AMENDMENT No. 4 TO ANNUAL HVAC CONTRACT

This agreement amends the contract between Palm Beach County (County) and Horizon Air Conditioning, Inc. (Contractor) authorized pursuant to Palm Beach County Resolution (R-2010-0067).

The contract provided that Contractor would act as one (1) out of a pool of six (6) approved annual HVAC Contractor working within the annual capacity as established below:

Amendment No. 1 dated September 30, 2010, was approved by FD&O Director and amended the contract to include the Inspector General language.

Amendment No. 2: 1) Renewal No. 1 extends the term of the original contract from January 12, 2011 through January 11, 2012; and 2) increases the total dollar value by \$2,000,000 for a new total contract value of \$4,000,000.

Amendment No. 3: 1) Renewal No. 2 extends the term of the original contract from January 12, 2012 through January 11, 2013; and 2) increases the total dollar value by \$2,000,000 for a new total contract value of \$6,000,000.

Amendment No. 4: 1) Renewal No. 3 extends the term of the original contract from January 12, 2013 through January 11, 2014; and 2) increases the total dollar value by \$2,000,000 for a new total contract value of \$8,000,000.

Except as amended herein, all provisions of the existing contract shall remain in full force and effect.
