I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: a Contract with Ric-Man International, Inc. in the amount of \$2,685,368 for the construction of Belvedere Homes Infrastructure Improvements – Phase 2, contingent upon approval by the Florida Department of Economic Opportunity.

On December 12, 2012, five (5) bids were opened for the Belvedere Homes Infrastructure Improvements - Phase 2 with Ric-Man International, Inc. being the lowest responsible responsive bidder in the amount of \$2,685,368. The drainage improvements include the construction of storm sewers and the grading of the swales. The potable water improvements include the replacement of asbestos cement water main pipes (9,700 ft in Phase 2), installation of new water services and fire hydrants. The wastewater system improvements include the construction of a vacuum type sewer collection system consisting of pipes providing wastewater services to 229 properties in Phase 2. The Water Utilities Department (WUD) will administer the project for Westgate/ Belvedere Homes Community Redevelopment Agency (CRA). Funding for this project has been provided by WUD, CRA and the Palm Beach County Department of Economic Sustainability (DES) under the Community Development Block Grant Disaster Recovery Initiative (CDBG DRI) Program. The partially Federally Funded Project has participation goals of 22.4% MBE and 6.9% WBE. The Contract with Ric-Man International, Inc. includes 22.73% MBE, 6.91% WBE participation. Although SBE participation is not required by the Contract, a Good Faith Effort as determined by DES, has been made by Ric-Man International, Inc., who provides for SBE participation of 27.07% overall. Ric-Man International, Inc. is a Broward County company. The Local Preference Ordinance is not applicable to this Federally funded project. (WUD Project No. 10-502) District 7 (JM)

Background and Justification: The Belvedere Homes Community is within the WUD's utility service area. Presently central wastewater service is available only to minority of the properties. This project will make wastewater service available to all property owners within the boundaries of the project, and improve the drainage within the road right-of-ways, replace the outdated asbestos cement water mains, and install new water services and fire hydrants. All sidewalks and driveways will be replaced and the roadways will be milled and overlaid throughout the limits of construction. WUD will not require the property owners to connect to the proposed sewer collection system. Property owners wanting to connect to WUD sewer system will have the option to enter into the Deferred Payment Plan for Service Initiation Fees. The Westgate/Belvedere Homes CRA has selected to proceed with Phase II of the project at this time, due to limits of funding time restrictions (the project must be completed by July 31 2013). There were a number of minor irregularities identified with the bid documents which are detailed in Attachment 5. Staff waived these minor irregularities as they did not provide the low bidder with any competitive or monetary advantage. There is no bid protest associated with this item.




