Water Utilities is requesting an extension of the contract for an additional three (3) months or until a new contract is awarded, whichever occurs first, and an increase of \$236,288 over the previously authorized amount of \$835,000, while Purchasing evaluates and awards a new bid. The increased amount is based on historical usage required for the remaining four (4) months of the term contract, inclusive of the requested three (3) month extension. This term contract has no renewal periods remaining. Awardee is located out of State. This is a sole source provider who is not a certified SBE.
