I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to: Receive and File Modification #1 to the Subgrant Agreement 11DS-9Z-10-60-01-445 with the State of Florida, Division of Emergency Management (FDEM) under the State Homeland Security Grant Program (SHSGP) Contract 2011 to extend the agreement from April 30, 2013 to June 30, 2013.

Summary: The County was awarded \$95,245 from the State of Florida Division of Emergency Management to conduct planning, training and exercise activities in order to develop, and enhance emergency preparedness capabilities. A request to extend the grant from April 30, 2013 to June 30, 2013 has been approved and is attached. R-2012-1731 gave the authority to the County Administrator, or his designee, to execute these agreements on behalf of the Board of County Commissioners. **Countywide (PGE)**

Background and Policy Issues: The SHSGP provides funds to build capabilities at the State and local levels through planning, training and exercise activities. SHSGP also supports the implementation of State Homeland Security strategies and key elements of the national preparedness architecture, including the National Preparedness Goal, the National Incident Management System and the National Response Plan.

MODIFICATION # 1 TO SUBGRANT AGREEMENT BETWEEN THE DIVISION OF EMERGENCY MANAGEMENT AND PALM BEACH COUNTY EMERGENCY MANAGEMENT

This Modification is made and entered into by and between the State of Florida, Division of Emergency Management ("the Division"), and Palm Beach County Emergency Management ("the Recipient") to modify Contract Number: **11DS-9Z-10-60-01-445**, which began on May 11, 2011 ("the Agreement").

WHEREAS, the Division and the Recipient have entered into the Agreement, pursuant to which the Division has provided a subgrant to Recipient under the State Homeland Security Grants Program of **\$95,245**; and
