I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to: approve an amended fee schedule to include a fee for the expedited processing of certification, modification of certification, and re-certification applications in the amount of \$300.00 effective July 1, 2013.

Summary: The Office of Small Business Assistance seeks Board approval to establish an amended fee schedule effective July 1, 2013 to include a fee for expedited processing of certification, modification of certification and re-certification applications in the amount of \$300.00. The Small Business Advisory Committee has reviewed the fee schedule and supports the recommendation. **Countywide (TKF)**.

Background and Justification: On November 18, 2008, the Board approved the fee schedule for the processing of certification, modification of certification and re-certification applications. Charging processing fees is not a new or unique concept. Currently, the School District of Palm Beach County, the Southern Florida Minority Supplier Development Council and the Miami/Ft. Lauderdale Minority Business Enterprise Center charge a processing fee for certification.

Because expedited certification, modification and re-certification are costly, time consuming and require a speedier process, the Office of Small Business Assistance can no longer provide such services at the application fee rate. The Office of Small Business Assistance has received 17 requests for expedited review in the past six months which required the Small Business Development Specialists to place their current workload on hold in order to process the application expeditiously prior to the bid opening/RFP due date.
