THIRD AMENDMENT TO LEGAL SERVICES AUTHORIZATION 2011-0353-C

THIS THIRD AMENDMENT, made and entered into this day of July, 2013, by and between PALM BEACH COUNTY, a political subdivision of the State of Florida, hereinafter referred to as "County," and Sundstrom, Friedman & Fumero, a Florida limited liability partnership, hereinafter referred to as "Outside Counsel".

WHEREAS, on October 4, 2011, County and Outside Counsel entered into Legal Services Authorization 2011-0353-C dated August 1, 2011 for Outside Counsel services related to the Glades Utility Authority (hereinafter the "GUA LSA"); and

WHEREAS, on January 24, 2012, County and Outside Counsel entered in the First Amendment to Legal Services Authorization 2011-0353-C (hereinafter the "First Amendment") modifying the Scope or Work and increasing the not-to-exceed amount from \$50,000 to \$100,000; and

WHEREAS, on December 4, 2012, County and Outside Counsel entered in the Second Amendment to Legal Services Authorization 2011-0353-C (hereinafter the "Second Amendment") modifying the Scope of Work and increasing the not-to-exceed amount from \$100,000 to \$175,000; and

WHEREAS, County and Outside Counsel wish to amend the GUA LSA to increase the not-to-exceed amount to \$225,000, and extend the expiration date to July 30, 2013.

NOW THEREFORE, in consideration of the mutual covenants and agreements expressed herein, the parties hereby agree as follows:

- 1. The recitals set forth above are true and correct and are incorporated herein by specific reference.
- 2. The not-to-exceed amount of the GUA LSA is hereby amended to \$225,000.
- 3. The expiration date of the GUA LSA is hereby extended to July 30, 2013.

4. All other provisions of the GUA LSA, dated August 1, 2011, as amended by the First Amendment, dated January 24, 2012, and as amended by the Second Amendment, dated December 4, 2012, are hereby confirmed and, except as provided herein, are not otherwise altered or amended and shall remain in full force and effect.
