I. EXECUTIVE BRIEF

Motion and Title: Staff requests direction regarding FY 2014 funding for the Office of Inspector General (OIG).

Summary: The proposed FY 2014 budget submitted by the Inspector General is \$3.7 million. This budget includes 40 positions, of which 23 are currently filled. The funding source for this budget is the County, Children Services Council, Solid Waste Authority, and municipalities. The proposed FY 2014 budget assumes municipalities would fund \$1.5 million of the total budget.

As a result of the law suit brought by the municipalities regarding the OIG funding, it is unlikely that there will be any resolution that would provide the OIG with any significant municipal funding during FY 2014. Additionally, the Health Care District cancelled their agreement resulting in a loss of revenue of \$298,000. If the OIG budget was reduced to only fund the currently filled positions (23), the total budget would be \$2.75 million. To maintain staffing at the existing level, an additional \$687,000 would be required from the County's General Fund. No funds are currently available in the FY 2014 budget at this time. If the Board chooses to fund this request, amendments to the FY 2014 proposed budget will be included in the 1st Public Hearing scheduled for September 9th. These amendments would increase the funding contribution from the County and reduce the overall budget to reflect only the 23 filled positions. Should the Board take this action, the 17 currently vacant positions will be reinstated once the municipal funding is implemented.

Without the additional funding from the County, the Inspector General will need to layoff six (6) employees by September 27^{th} and another three (3) by December 27^{th} . <u>Countywide</u> (LB)

Background and Policy Issues:

In May 2011, the Board of County Commissioners adopted the OIG ordinance. The ordinance includes a funding formula, which proportionately distributes the cost between the County and municipalities based on actual expenditures levels. In November 2011, fifteen municipalities filed suit questioning the legality of this funding mechanism of the OIG. In response to this suit, the Clerk and Comptroller refused to allocate municipal revenues to fund the OIG. Given that the litigation with the cities is ongoing and not likely to end in this near future, the prospect of recovering from the cities any amount over and above the County's share required by ordinance is uncertain. The County Attorney's Office has consistently recommended against putting funds at risk in the face of ongoing litigation, but recognizes the Commission's prerogative in determining that it serves a public purpose to advance this amount.

Dear Mayor Abrams and Board of County Commissioners,

I have been recently informed by County staff that there will not be a proposal put forth to you to fully fund our office for the remainder of the lawsuit which was filed by the 14 municipalities, as once discussed. This office cannot continue to operate at current capacity without a stable funding base each year. Currently we have only 23 (57.5%) of our 40 allocated positions filled. However, due to the continued absence of municipal funding, with those 23 positions we anticipate a shortfall for FY2013-14 of \$815,000.

There are only two options for resolving this gap. One option is for the Board of County Commissioners to agree to fund this shortfall, and ultimately seek restitution from the municipalities. The only other option is for me to reduce OIG personnel services to coincide with anticipated funding. Because salaries constitute the major component of our costs, notification of layoffs must occur immediately beginning with 26% of staff being affected by end of September 27, 2013 and subsequent additional layoffs of approximately 13% of staff would be affected by December 27, 2013.

I respectfully request that this issue be placed on the agenda to go before the Commission for its consideration, and decision at its meeting next Tuesday, August 13, 2013. A decision by the Commission next Tuesday to hopefully fund this shortfall will place our staff at ease and enable us to continue with our current level of operations. If this item is not placed on the agenda for Tuesday, I will have no choice but to immediately issue employee layoff notices in order to provide staff with a professional level of notice.

Thank you for your consideration in this urgent matter.
