| The County has encumbered \$906,613 (\$82,419/month) during the previous eleven (11) months of the current twelve (12) month term contract. Based upon historical usage and an anticipated increase in transportation collections due to a historical annual increase in transport volume and an anticipated ncrease of the emergency transport fee, \$20,604,658 in revenue is anticipated to be generated during this twelve (12) month renewal term. Of this amount, the contractor will be paid 5.5% on non Medicaid gross monthly collections and .49% of non Medicaid net monthly collections (for use of fripTix Software), which is estimated to be a total of \$1,235,000 (\$102,917/month). This term contract has no renewal periods. Awardee is located butside Palm Beach County in the City of Fort Lauderdale, Florida. The County has encumbered \$149,454 (\$10,676/month) collectively among two (2) separate contracts for grounds maintenance at various locations during the previous fourteen (14) months of the current term contracts. Based upon fixed fees per location (\$145,392); estimated mulch (\$58,613) and estimated fertilizer (\$12,995), \$217,000 is needed to meet the County's requirements through the expiration of this new twelve (12) month term contract. The sixty-nine percent (69%) increase is due to the consolidation of these two (2) contracts, new vendor pricing and additional services required (mulch and fertilizer application). This term contract has four (4) twelve (12) month renewal periods. Two (2) Awardees are located in Palm Beach County and one (1) Awardee is located outside Palm Beach County in the City of Miramar, Florida. No responsive SBE vendor bid within 10% of the low bidder.


