### I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to receive and file:** a fully executed Amendment 1 to Agreement with the State of Florida Department of Environmental Protection (FDEP) for Land and Water Conservation Fund (LWCF) Project Number 12-00583 for John Prince Memorial Park - Phase IV to extend the project completion date from March 14, 2014, to March 14, 2015.

**Summary:** On May 18, 2010, the Board authorized submission of a LWCF grant application for improvements at John Prince Memorial Park Phase IV (R2010-0792). The Board also authorized the County Administrator or his designee to execute the Project Agreement and other standard state and/or federal grant forms related to this project. The grant was approved and the Project Agreement, R2011-1058, provided a grant term from March 14, 2011, to March 14, 2014. The County requested an Amendment to the Agreement extending the grant term for one year. The Director of Parks and Recreation Department executed the Amendment on behalf of the Board as authorized, and the Amendment is now being presented to the Board to receive and file. **Background and Justification:** LWCF grants are funded by the U.S. Department of the Interior and administered by the Florida Department of Environmental Protection. Project elements include construction of a canoe/kayak launch, bike path, picnic facilities, parking and landscaping; as well as renovation of the cricket field, volleyball court, picnic facilities, lakeside bike trail, playground, parking, landscaping, restroom, and other related support facilities.
