EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to adopt: a resolution confirming the special assessment process for the El Paso Drive, Pinto Drive and Pancho Way, east of Blanchette Trail paving and drainage improvement (Project).

SUMMARY: Adoption of this resolution will allow Palm Beach County to assess the fixed amount of \$10,000 to each property owner. The Board of County Commissioners assigned a fixed assessment for this Project at the October 16, 2012 meeting. Assessments will be payable in 20 equal annual installments at an interest rate of 5% per annum. The Project includes new roadway pavement, driveway reconstruction, and a storm water management system.

District 6 (MRE)

Background and Policy Issues: The Board of County Commissioners (Board) approved proceeding with the "U" option of the Project at the February 5, 2013 meeting. At the July 16, 2013 Board meeting, an amendment to the Palm Beach County Municipal Services Taxing Unit (MSTU) Special Assessment Ordinance which included adding flexibility for the public hearing timeframe for fixed assessment projects such as this, was approved. The total assessment for the Project was fixed at \$10,000 per property at the October 16, 2012 Board meeting. The fixed amount will not be affected by the various costs incurred during design, bidding or construction. The Engineering and Public Works Department advertised the Project for a public hearing on Sunday, September 15, 2013 and Sunday, September 22, 2013. A comprehensive explanation of the proposed improvements was distributed by regular mail to the property owners to be assessed in lieu of a public information meeting as allowed for in Section 26-302 MSTU Special Assessment Ordinance.



RESOLUTION NO. R-2013-

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA CONFIRMING THE SPECIAL ASSESSMENT FOR EL PASO DRIVE, PINTO DRIVE AND PANCHO WAY EAST OF BLANCHETTE TRAIL **PAVING** AND DRAINAGE IMPROVEMENT PROJECT, SECTION 20, TOWNSHIP 44 SOUTH, RANGE 42 EAST, PURSUANT TO A PUBLIC **HEARING HELD THEREON.**

WHEREAS, a special assessment process was initiated for the paving and drainage improvement of El Paso Drive, Pinto Drive and Pancho Way east of Blanchette Trail, authorized pursuant to Palm Beach County Code Chapter 26, Article II, Division 1, known as the Municipal Service Taxing Unit (MSTU) Special Assessment Ordinance; and

WHEREAS, the Board of County Commissioners set a fixed amount of \$10,000 for the cost of the paving and drainage improvement, which is funded through the MSTU Program, will be repaid by special assessment upon specially benefited parcels of land; and

WHEREAS, the method of assessment is to be on a per lot basis; and

WHEREAS, pursuant to Section 26-30.3, the Board of County Commissioners did hold a public hearing on the 1st day of October, 2013 at the Commission Chambers of the Board of County Commissioners of Palm Beach County, Florida, so as to satisfy the requirements of the MSTU Special Assessment Ordinance; and

WHEREAS, the Board of County Commissioners finds that the public notice and public hearing requirements of the MSTU Special Assessment Ordinance have been met.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, THAT:

The Report of Costs and the Special Assessment Roll for the paving and drainage improvement of El Paso Drive, Pinto Drive and Pancho Way east of Blanchette Trail, Section 20, Township 44 South, Range 42 East, is on file in the office of the Clerk of the Board of County Commissioners and attached hereto as EXHIBIT I and EXHIBIT II respectively and is hereby approved and confirmed and shall be recorded by the Clerk of the Board of County Commissioners in a special book to be known as "The Improvement Lien Book" and the record of the lien in said book shall constitute prima facie evidence of the validity of said lien and shall be placed on the tax rolls.

- 1. The said special assessments are hereby made upon all parcels of land described in said Special Assessment Roll in the amount shown thereon.
- 2. Pursuant to the MSTU Special Assessment Ordinance, the following project is hereby approved: El Paso Drive, Pinto Drive and Pancho Way east of Blanchette Trail Paving and Drainage Improvement, Section 20, Township 44 South, Range 42 East, Palm Beach County, Florida.
- 3. The said special assessments are hereby made upon all parcels of land described in said Special Assessment Roll (EXHIBIT II) in the amount shown thereon.
- 4. Pursuant to the MSTU Special Assessment Ordinance, any and all special assessments made pursuant to this Resolution, which have not been paid in full within thirty (30) days after notice of completion of the subject improvements for which said assessment was made, shall be subject to interest at a rate of five percent (5%) per annum from the date of the acceptance of said improvement by Palm Beach County and shall be payable in twenty (20) equal annual installments.
- 5. The total cost of the paving and drainage improvements funded through the MSTU Program is estimated at \$1,464,500. A special assessment in the fixed amount of \$10,000 per lot shall be collected towards the total costs of the paving and drainage improvements funded through the MSTU Program.
- 6. The Board of County Commissioners finds that each parcel listed on EXHIBIT II will obtain a special benefit which is at least equal to the amount of special assessment made against each such parcel.
- 7. Pursuant to Section 26-30.6 of the MSTU Special Assessment Ordinance, if any special assessment made under this resolution shall be either in whole or part vacated or set aside by the judgment of any court, or the Board of County Commissioners, shall be satisfied that any such assessment is so defective that the same cannot be enforced or collected, or if the Board will have omitted to make any such assessment when it might have done so, the Board of County Commissioners will take all necessary steps to cause a new assessment to be made for any improvement against any property specially benefited by such improvement.
