Due to the need for exotic vegetation control/removal that has exceeded their estimated expenditures for the year, Parks & Recreation is requesting an increase of \$370,000 for exotic vegetation control/removal at various park locations; Environmental Resources Management is requesting an increase of \$300,000 for exotic vegetation control/removal to complete work at the Cypress Creek Natural Area; and Water Utilities is requesting an increase of \$62,000 for exotic vegetation control/removal due to additional sites acquired and unanticipated needs at existing locations for a total increase of \$732,000 over the previously authorized amount of \$710,000. 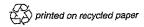

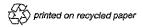
