I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Eighteenth Amendment to contract with CGI Technologies and Solutions, Inc. (CGI) (R2002-1782), to extend the ending date of the Statement of Work from December 31, 2013 to December 30, 2014, at no additional cost to the County.

Summary: The Eighteenth Amendment is a date extension to allow additional time for completion of the deliverables specified in the original contract, including vendor self-service and Modification No. 11. CGI Technologies and Solutions, Inc. is not a Palm Beach County or Florida-based business. <u>Countywide</u> (PFK)

Background and Justification: On October 2, 2002, the Board approved the migration of the County's Finance System from the mainframe-based LGFS version to the web-based Advantage System. The implementation and installation of Phase I of the Vendor Self Service (VSS) Online Registration module are complete but VSS Phase II for On-line Bidding and Solicitations' has not yet been implemented.

The Eighteenth Amendment also provides additional time for Modification No. 11, which will provide the ability to systematically process mass reorganizations or changes in Fund types in an efficient manner.


WHEREAS, the CONTRACTOR and the COUNTY require additional time to complete the deliverables specified in the original contract, including vendor self-service and modification No. 11;
