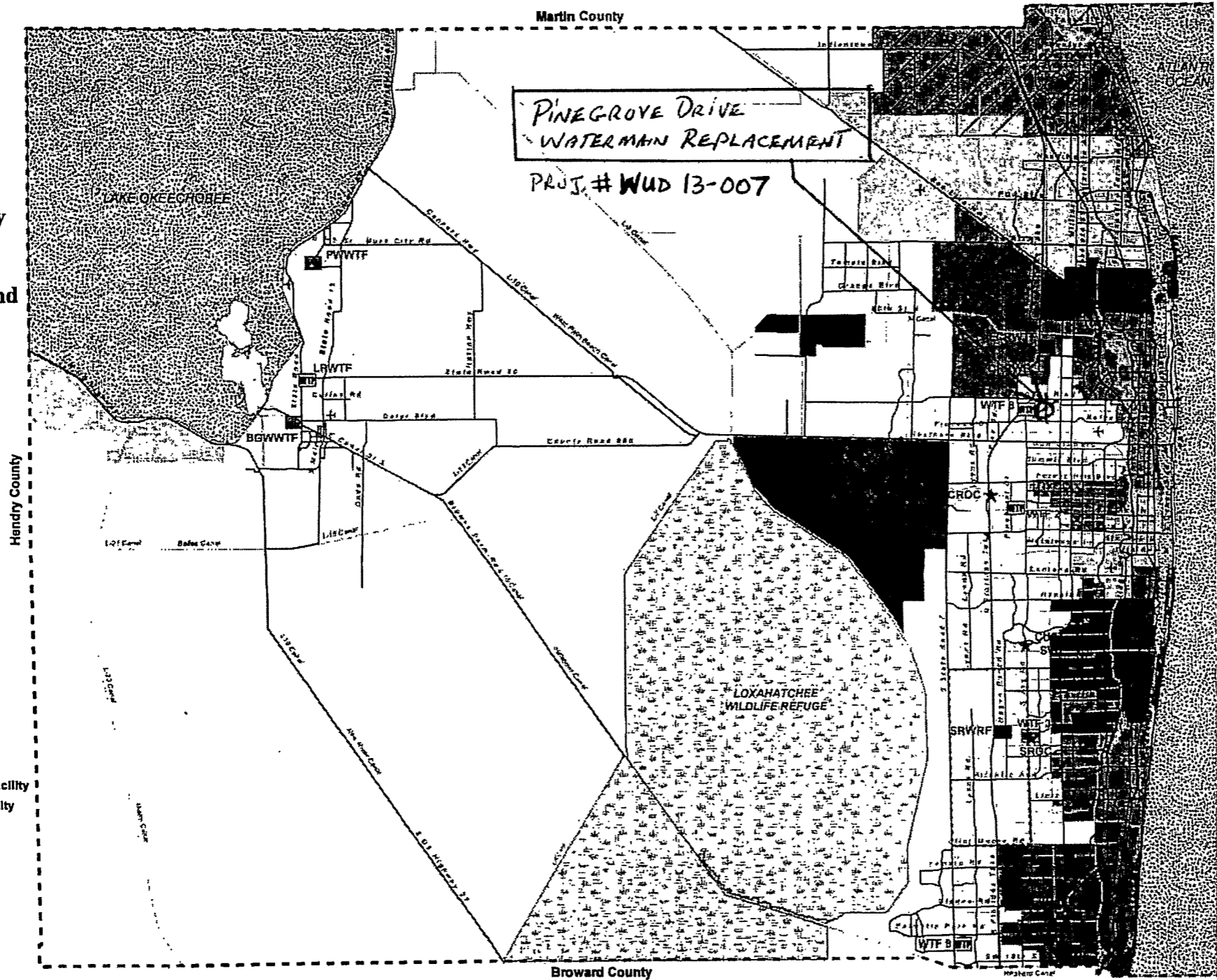

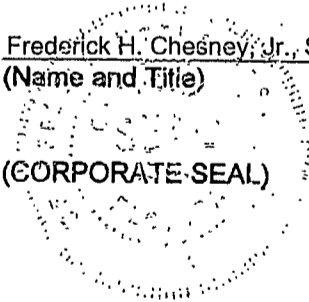

INTRODUCTION

Palm Beach County (County) entered into an agreement entitled Contract for Pipeline Continuing Construction Services - Palm Beach County Water Utilities Department Project No. WUD 13-007 (CONTRACT) with Centerline Utilities, Inc. (CONTRACTOR) to provide construction services for various general activities on the Pipeline Continuing Construction Contract dated May 7, 2013, (R2013- 0551). This Work Authorization will be performed under that CONTRACT.

This Work Authorization encompasses providing services related to Pinegrove Drive Haverhill Road to the LWDD E-3 Canal 8" AC Water Main Replacement

SCOPE OF SERVICES

Contractor shall perform the engineering Scope of Services as described herein Removal of an existing 8-inch Asbestos Cement Water Main along LWDD L-2 Canal north right of way/Pinegrove Drive between LWDD E-3 Canal and Haverhill Road, and replacement with 2660 linear feet 8-inch DIP Water Main.

COMPENSATION

Compensation shall not exceed \$293,894.95 in accordance with the unit prices established in the Contract for construction services dated May 7, 2013 as approved by the Board of County Commissioners.



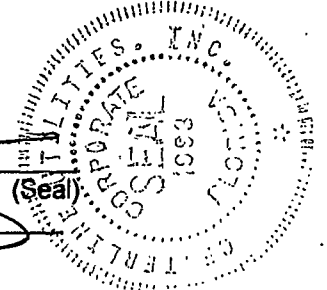

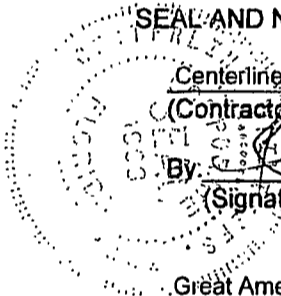
