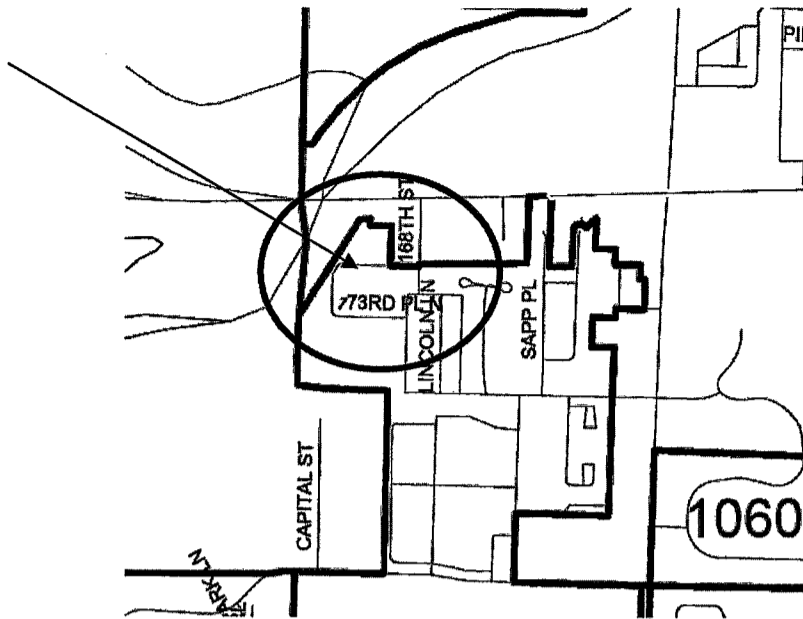

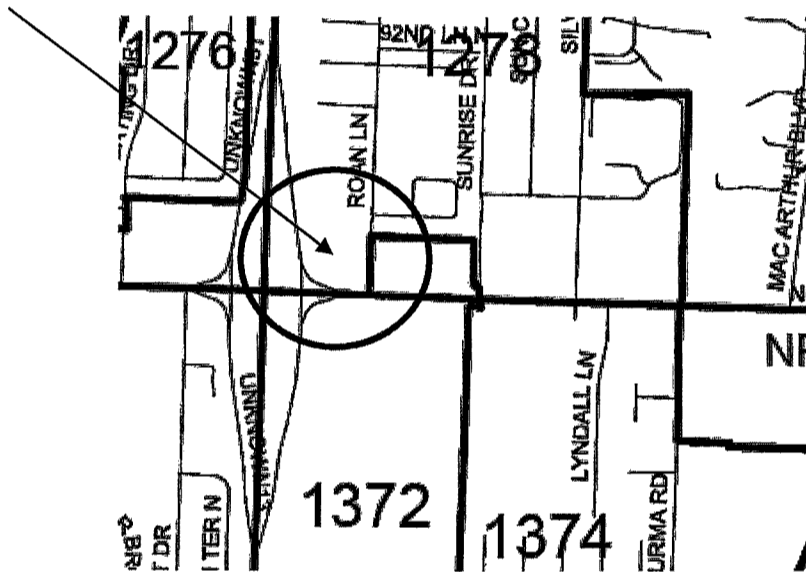

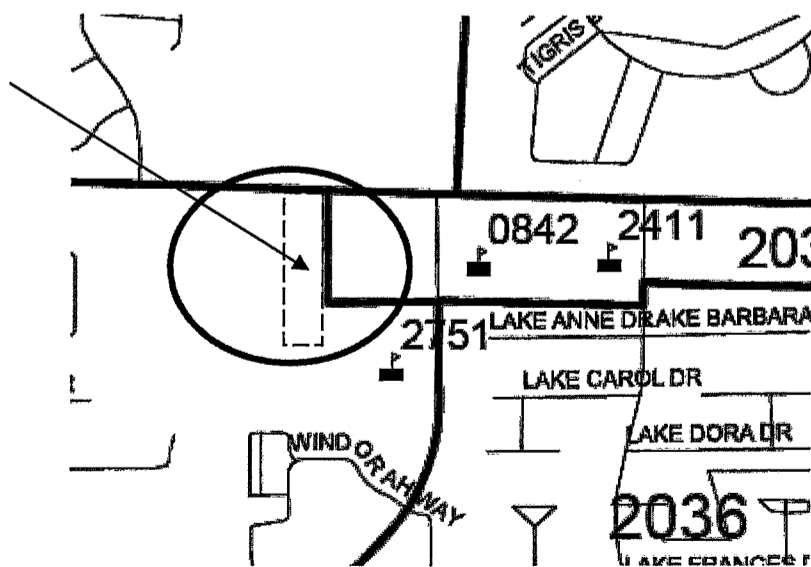
Pct 1046 - 1056



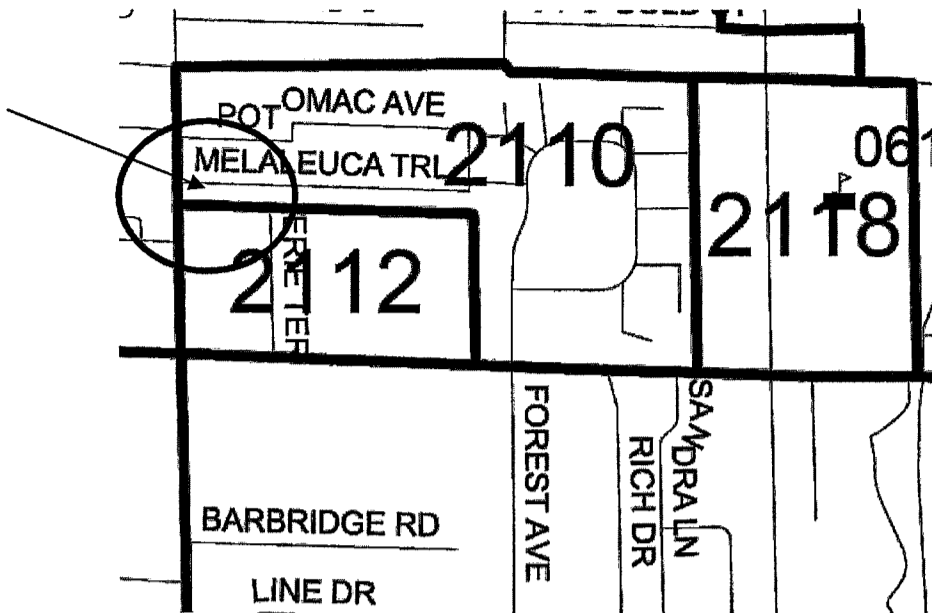

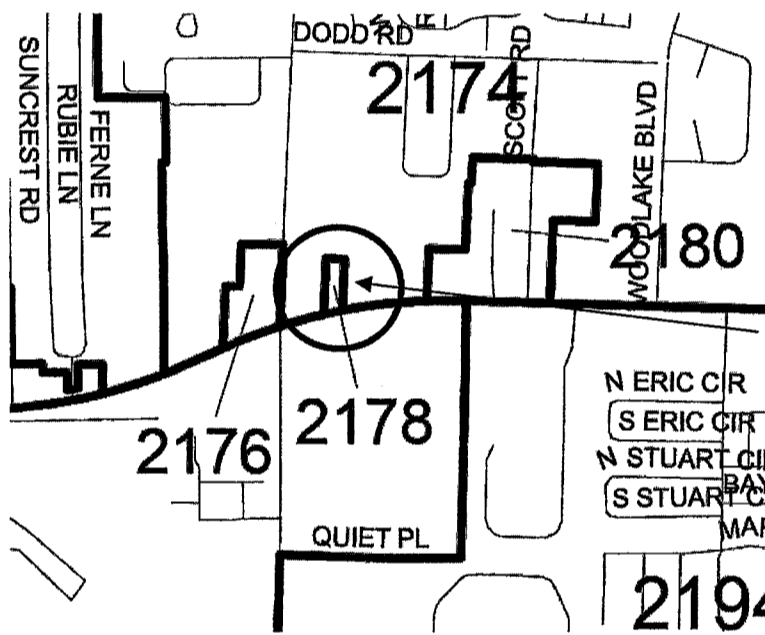

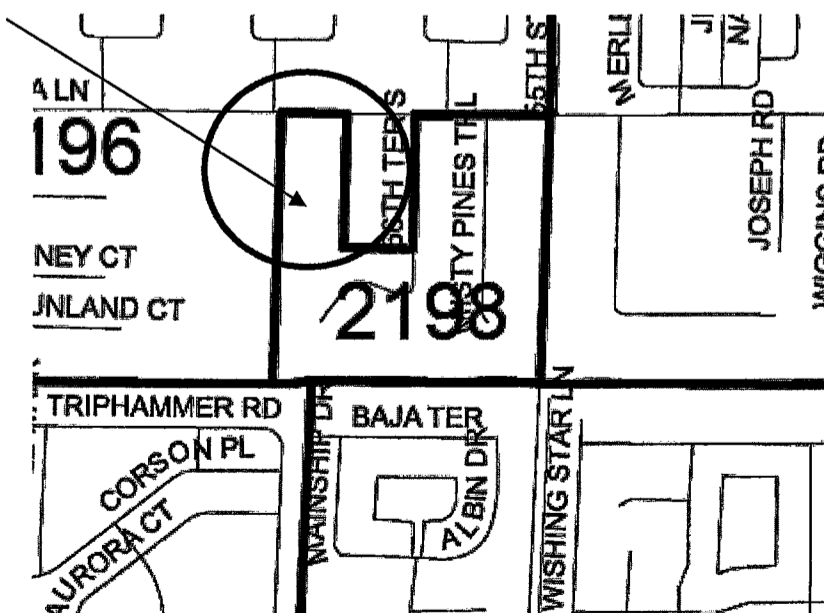

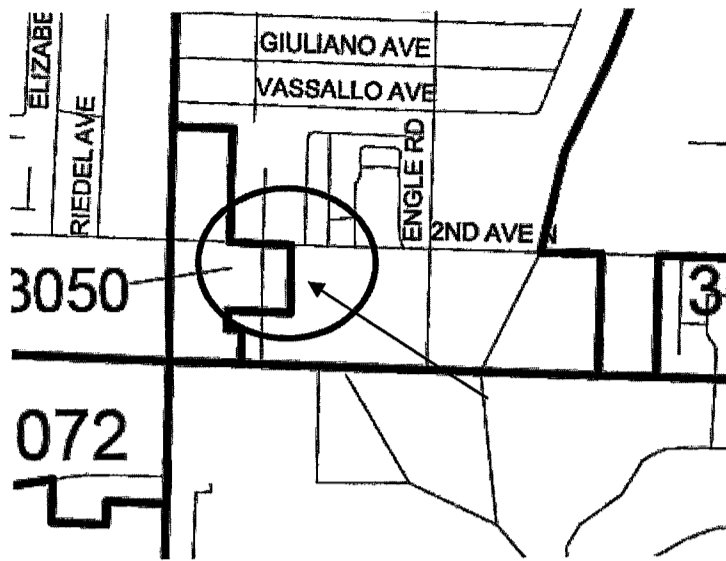
