I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to: A) Approve a Reinstatement and Amendment to the original agreement with Children's Home Society of Florida (R2011-0776-Original Agreement; R2012-1847 First Amended Agreement) to extend the agreement for an additional twelve months to September 30, 2014 and increase the agreement amount by \$12,000 for a new total not to exceed amount of \$52,400 to continue providing professional services in the area of Family Drug Court/Dependency proceedings; and B) Approve a Reinstatement and Amendment to the original agreement with Drug Testing and Counseling Services, Inc. (R2010-0654-Original Agreement; R2012-1848 First Amended Agreement) to extend the agreement for an additional twelve months to September 30, 2014 and increase the agreement amount by \$22,000 for a new total not to exceed amount of \$91,300 to continue providing drug testing services to the Family Drug Court program; and C) Receive and File the approved Family Drug Court Grant (2009-DC-BX-0115) adjustment notice to extend the grant period for an additional twelve months to September 30, 2014.

Summary: The Division of Justice Services, in conjunction with the Department of Children and Families Substance Abuse and Mental Health Office applied for and was awarded a grant from the Office of Justice Programs in the amount of \$484,907 to develop a Family Drug Court program in 2009 to address substance abuse and other issues affecting the parent(s) of children in new dependency petitions. A request to extend the grant to September 30, 2014 was approved in order to fully expend the grant award. Therefore, amendments to the Children's Home Society and the Drug Testing and Counseling Services, Inc. agreements are necessary. Countywide (PGE)

Background and Justification: The Palm Beach County Family Drug Court is an intervention model which emphasizes a holistic focus on strengthening families by offering extensive and comprehensive wraparound services to the substance abusing parent. affected children, as well as relatives and partners that are individualized to the needs of each family member.

Background and Justification (Continued from page 1): Cohesive linkages among stakeholders in the child welfare, substance abuse treatment, and judicial systems assure that effective communication occurs through family drug court team collaboration, with representatives from all involved systems claiming team membership and providing accountability. This three year grant began on October 1, 2009 and the Family Drug Court Coordinator was hired six months later in April 2010 and the first clients entered the program in July 2010. Therefore, a request to extend the grant from September 30, 2012 to September 30, 2013 was approved. On April 20, 2010 and May 17, 2011, the Board of County Commissioners approved agreements with Drug Testing and Counseling Services, Inc. in the amount of \$69,300 and Children's Home Society of Florida in the amount of \$20,000 respectively.

AGREEMENT REINSTATING AND AMENDING THE TERMS OF ORIGINAL AGREEMENT, AS AMENDED WITH CHILDREN'S HOME SOCIETY OF FLORIDA TO PROVIDE SOCIAL SERVICES TO FAMILY DRUG COURT CLIENTS

THIS AGREEMENT (hereinafter "Agreement") dated ______, by and between Palm Beach County, a Political Subdivision of the State of Florida, by and through its Board of Commissioners (hereinafter referred to as "COUNTY,") and The Children's Home Society of Florida (hereinafter referred to as the "CONSULTANT") whose Federal ID is 59-0192430), reinstates and amends the Original Agreement ("Original Agreement" R-2011-0776) dated May 17, 2011, as amended on December 4, 2012 (R-2012-1847) to provide social services to the Family Drug Court Program.

WITNESSETH:

WHEREAS, the COUNTY and the CONSULTANT entered into the Original Agreement (R-2011-0776) on May 17, 2011, with an effective date of April 1, 2011, and a termination date of September 30, 2012, stemming from the Office of Justice Programs FY 2009 Family Drug Court Program Grant, of which CONSULTANT received a contract from the COUNTY not to exceed \$20,000; and

WHEREAS, the Original Contract was amended (R-2012-1847) to increase the contract price an additional \$20,400 and extended the termination date until September 30, 2013; and


WHEREAS, the total underlying grant funds have not fully been expended through no fault of the parties; and

WHEREAS the Office of Justice Programs has approved the County's revised budget allowing for the redistribution of funds to this CONSULTANT in the amount of \$12,000, as well as an extension of time to continue the Family Drug Court Program until September 30, 2014.

NOW THEREFORE, in consideration of the mutual representations, terms, and covenants hereinafter set forth, the parties hereto agree as follows:

- 1. The Original Agreement (R-2011-0776), as amended (R-2012-1847), is reinstated in its entirety.
- 2. The termination date as referenced in Article 2 (Schedule) of the Original Agreement is amended to September 30, 2014.
- 3. The contract price as referenced in Article 3 (Payments to Consultant) in the Original Agreement is increased an additional \$12,000, making the total amount to be paid by COUNTY to the CONSULTANT for social services under the Original Agreement, as amended, an amount not to exceed \$52,400. The new schedule of payments, as amended and referenced herein, is attached hereto as "Exhibit BB Schedule for Payment as Amended" showing the new total budget.
- 4. All other provisions of said Original Agreement, as amended, are hereby confirmed, and except as provided herein, are not otherwise altered or amended and shall remain in full force and effect.


