EXECUTIVE BRIEF I.

Motion and Title: Staff recommends motion to approve:

A) Budget transfer in the amount of \$181,476 in the 30.5M GO 03 Bond Fund from the Reserves to the Library Annex Project;

Budget transfer in the amount of \$834,446 in the 22.3M GO 06 Bond Fund from the Reserves to **B**) the Library Annex Project;

Budget transfer in the amount of \$2,607,029 in the Library Expansion Program Fund from the C) Reserves to the Library Annex Project;

Budget transfer in the amount of \$1,594,001 in the Library Impact Fees Fund from the Reserves to **D**) the Library Annex Project; and

Amendment No. 3 to the contract with The Weitz Company, LLC (R-2012-1001) in the amount of E) \$4,311,056 for construction management services for Library Annex located on Cherry Road in West Palm Beach.

Since 1999, the County on behalf of the Library Department has leased space within the Summary: Mil-Lake Plaza located on Lake Worth Road in Greenacres. The final renewal option to the lease will expire March 31, 2015. This Amendment will provide for the construction of a stand-alone facility to meet the Library Department's needs to replace the existing leased space. The Library Annex provides for acquisition, preparation, and storage of library materials, as well as the Outreach Services Section which includes talking books, books by mail, the bookmobile and the volunteer literacy tutoring program. The construction will include structural, mechanical, plumbing, electrical, landscaping irrigation and site improvements. The time of construction is 297 days. The Weitz Company, LLC has a continuing construction management services contract which provides for Small Business Enterprise (SBE) participation goal of 15%. The Weitz Company, LLC's proposed SBE participation for this project is 18.2%. The Weitz Company, LLC is a Palm Beach County firm and is using 71% Palm Beach County subcontractors. Amendment No. 3 is funded by General Obligations Bonds issued in 2003 and 2006, Impact Fees, and Ad Valorem taxes. (Capital Improvements Division) Countywide/District 7 (JM)

On July 27, 1999, the Board approved the initial lease agreement for a **Background and Justification:** period of six years with two options to extend each for one year. On November 20, 2012, the Board (Continued on page 3)



AMENDMENT NO. 3 TO CONTRACT FOR CONSTRUCTION MANAGEMENT SERVICES WITH THE WEITZ COMPANY, LLC FOR THE LIBRARY ANNEX PROJECT NO. 13201

WHEREAS, the Owner and Construction Manager acknowledge and agree that the Contract between Owner and Construction Manager (The Weitz Company, LLC) dated 07/10/2012 (R2012-1001) is in full force and effect and that this merely supplements said Contract;

WHEREAS, the parties hereto entered into a Contract between Owner and Construction Manager whereby the Construction Manager has rendered or will render pre-construction services as specified therein; and

WHEREAS, the parties have negotiated a Guaranteed Maximum Price, including Construction Managers fees for construction and warranty services and other services as set forth herein and in the Contract;

WHEREAS, the Construction Manager represents that the Construction Manager, Subcontractors, material and equipment suppliers have compared Phasing, Demolition, Architectural, Structural, Mechanical, Electrical, Plumbing, Civil and Site Drawings and Specifications and have compared and reviewed all general and specific details on the Drawings and that all conflicts, discrepancies, errors and omissions, which are within the commonly accepted knowledge based of a licensed general contractor, subcontractor, trades persons, manufacturers or other parties required to carry out the Work involved in this Amendment, have been corrected or clarified prior to execution of this GMP Amendment to the Contract, and therefore Construction Manager warrants that the GMP (exclusive of contingency) includes the cost of correcting all conflicts, discrepancies, errors, or omissions which Construction Manager identifies, or should have identified through the exercise of reasonable skill and care, during the preconstruction phase of this Contract.

WHEREAS, the Construction Manager's review and comparison of all Drawings has taken into consideration the total and complete functioning of all systems and therefore the Construction Manager represents that the GMP represents the total cost for complete and functional systems.

NOW THEREFORE, in exchange for the mutual covenants and promises set forth herein and the sums of money agreed to be paid by the Owner to the Construction Manager, the parties agree as follows:

GUARANTEED MAXIMUM PRICE (1)

> Pursuant to Article 2.2 and Article 6 of the Contract between Owner and Construction Manager, the parties have agreed to the establishment of a Guaranteed Maximum Price of \$4,311,056 for the construction costs of Library Annex. Refer to Exhibit A.

SCHEDULE OF TIME FOR COMPLETION (2)

> Pursuant to Article 5.3, Construction Manager shall substantially complete the project within 297 calendar days of receiving the Notice to Proceed with construction work from the Owner. Liquidated Damages are \$510.00/day for failure to complete within the contract time or approved extension thereof.
