I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Work Authorization No. 4 for 16inch Reclaimed Water Main (RCWM) extension along Lyons Road from LWDD L-26 to LWDD L-28 Canal with Centerline Utilities, Inc. in the amount of \$614,244.07.

Summary: On May 7, 2013, the Palm Beach County Board of County Commissioners approved the Water Utilities Department Pipeline Continuing Construction Contract (R2013-0551) to Centerline Utilities, Inc. This Work Authorization No. 4 provides for the installation of 5,500 ft of 16" Ductile Iron Pipe (DIP) reclaimed water main pipe along the west side of Lyons Road between north side of LWDD L-26 Canal and the north side of LWDD L-28 Canal. The Small Business Enterprise (SBE) participation goal established by the SBE Ordinance (R2002-0064) is 15% overall. The contract with Centerline Utilities, Inc. provides for SBE participation of 15%. This Authorization includes 17.07% overall participation. The cumulative SBE participation is 15.47% overall. Centerline Utilities, Inc is not a Palm Beach County company. This project is included in the FY13-14 Capital Improvement plan adopted by the Board of County Commissioners. (WUD Project No. 13-041) District 5 (MJ)

Background and Justification: This Work Authorization is to interconnect the existing 16" DIP RCWM north of LWDD L-26 with a dry 16" Road DIP RCWM pipe south of LWDD L-28 and provide RCWM service to Canyon Lakes Community and future communities along Lyons Road.



INTRODUCTION

Palm Beach County (County) entered into an agreement entitled Contract for Pipeline Continuing Construction Services - Palm Beach County Water Utilities Department Project No. WUD <u>13-041</u> (CONTRACT) with <u>Centerline Utilities, Inc.</u> (CONTRACTOR) to provide construction services for various general activities on the Pipeline Continuing Construction Contract dated <u>May 7, 2013</u>, (R 2013-0551). This Work Authorization will be performed under that CONTRACT.

SCOPE OF SERVICES

Contractor shall perform the engineering Scope of Services as described herein Installation of 5,500 ft of 16" DIP Reclaimed Water Main along west side of Lyons Rd, from the L-26 to the L-28 Canal

COMPENSATION

Compensation shall not exceed <u>\$614,244.07</u> in accordance with the unit prices established in the Contract for construction services dated <u>May 7, 2013</u> as approved by the Board of County Commissioners.
