I. EXECUTI	VE BRIEF

Motion and Title: Staff recommends motion to approve: payment in the amount of \$1,114.18 to Florida East Coast Railway L.L.C. (FEC) for a railroad flagman that was required to facilitate a survey along Old Dixie Highway in order to determine the extent of the Palm Beach County (County) encroachment into the FEC right-of-way.

SUMMARY: This approval will authorize payment for the services of the flagman that was required by FEC for the County to survey along Old Dixie Highway between Yamato Road and Linton Boulevard to ascertain the limits and extent of the County's encroachment into the FEC right-of-way. As the survey was needed to verify an existing condition, and as there is no current agreement with the FEC to authorize payment as required by the County Finance Department, therefore, approval from the Board of County Commissioners is required in order to pay the outstanding invoice.

District 4 (MRE)

Background and Justification: In July 2012, the FEC informed the County that it was encroaching upon FEC's right-of-way adjacent to Old Dixie Highway between Yamato Road and Linton Boulevard without an agreement. Engineering staff investigated and confirmed there was an encroachment of the Old Dixie Highway right-of-way. The County surveyed along Old Dixie Highway to ascertain the extent of the right-of-way encroachment. The encroachment was verified to exist from north of the South Florida Water Management District C-15 Canal to Linton Boulevard. In order for the County to do the survey it was necessary to enter and work within FEC right-of-way. The FEC requires their flagman be present whenever anyone works within their right-of-way. The invoice of \$1,114.18 is for their flagman's time during the survey.


