## Background and Justification: (Continued from Page 1)

The Palm Beach County Section 108 Loan Program (Program), which is administered by the Palm Beach County Department of Economic Sustainability, was developed to create a source of loan funding for use by businesses and investors to implement business ventures that will create new jobs and help revitalize communities. Funding for the Program is received from the U.S. Department of Housing and Urban Development (HUD)

Program funds in the amount of \$1,412,000 allocated to Glades Plaza Enterprises, LLC, will assist in the renovation and expansion of an existing 88,000 square foot commercial shopping center located at 1504 SW 16 Street in Belle Glade. This project will meet HUD's national objective by providing 42 full-time jobs at an average salary of \$33,619.

Program funds in the amount of \$21,000 allocated to Samar Barhoush, Abdul Shatara and Ghasiba Shatara, in addition to \$10,181 of Brownfield Economic Development Initiative Grant funds, will assist in the interior and exterior renovation of a commercial property located at 172 West Avenue A in Belle Glade. This project will meet HUD's national objectives by creating three (3) full-time jobs.

Program funds in the amount of \$455,000 allocated to Schomburg Latin America, LLC, will assist in providing working capital for company operations. The company is located at 833 West 13 Street in Riviera Beach. This project will meet HUD's national objectives by providing 19 full-time jobs.
