#### **EXECUTIVE BRIEF**

**Motion and Title: Staff recommends motion to approve:** A contract with Green Construction Technologies Inc. (Green) in the amount of \$248,398 for the construction of Loxahatchee River Road gravity wall repairs (Project).

**SUMMARY:** Approval of this contract will allow Palm Beach County to issue a notice to proceed to Green, a Broward County company, to begin construction of the Project. The Palm Beach County Small Business Enterprise (SBE) goal for all projects is 15% overall. The SBE participation proposed for the Project by Green is 1.61%. None of the other bidders met the SBE 15% goal.

**Background and Justification:** Bids for the Project were received by the Palm Beach County Engineering Department on February 11, 2014. Green was the lowest responsive, responsible bidder. The Office of Small Business Assistance issued its evaluation on February 27, 2014. Time to complete all work under this contract shall be no more than 60 calendar days.


