I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: Various executed License Agreements as follows:

- 4. Standard License Agreement for Use of County-Owned Property with Boca Delray Division US Naval Sea Cadet Corp (Eagle Academy).

Summary: In accordance with County PPM CW-O-051, all delegated contracts, agreements and grants must be submitted by the initiating Department as a receive and file agenda item. The attached Standard License Agreements, dated from December 30, 2013 to March 11, 2014, have been fully executed on behalf of the Board of County Commissioners (Board) by the County Administrator or his designee in accordance with R2010-0333, as amended and approved by the Board on October 1, 2013 (the "Resolution"). These executed documents are now being submitted to the Board to receive and file. (FDO Admin) Countywide (MJ)

Background & Justification: The Resolution which provided authority for the County Administrator or his designee to execute commercial license agreements was designed to expedite and streamline the process for commercial use of county owned property after submission of an application for use and after determination of whether a license fee should be charged for the use. There is no license fee if the applicant demonstrates that (i) the activity is for the purpose of promoting community interest and welfare and (ii) the applicant will not realize a profit based on the use. PPM CW-O-051 requires the executed agreements be submitted for filing.
