AMENDMENT TO CONTRACT FOR ANNUAL CONSTRUCTION MANAGEMENT SERVICES CONTINUING CONTRACT BASIS

This Amendment No. 7 dated _______, to the Contract (R-2012-1002) dated July 10, 2012, by and between Palm Beach County, a political subdivision of the State of Florida, by and through its Board of Commissioners, hereinafter referred to as the COUNTY and Trillium Construction Inc, a corporation authorized to do business in the State of Florida, hereinafter referred to as the CONSTRUCTION MANAGER.

WITNESSETH

WHEREAS, the parties have entered into a Contract under which the CONSTRUCTION MANAGER provided certain construction management services to the COUNTY for various projects; and

WHEREAS, the parties hereto desire to amend the Contract to extend it for an additional two (2) year period.

 "Except as specifically and expressly provided for herein, no provision of this Contract is intended to, or shall be construed to, create any third party beneficiary or to provide any rights to any person or entity not a party to this Contract."
- 3. Except as specifically modified above, the terms and conditions of the Contract are hereby confirmed and remain in full force and effect.
