I. EXECUTIVE BRIEF
<b>Motion and Title:</b> Staff recommends motion to approve: a budget amendment the Fire Rescue MSTU Fund (1300) in the amount of \$5,000 to recognize a donatic received from Palm Beach County Volunteer Fire Rescue for the Drowning Prevention Coalition swim lessons program.
<b>Summary:</b> On January 24, 2014, the County received a monetary donation in the amount of \$5,000 from the Palm Beach County Volunteer Fire-Rescue. The done requested the monies be used to fund additional swim lessons through the Palm Beach County Drowning Prevention Coalition's (DPC) Swim Bucks program. The funds from this donation will be utilized to offer an additional one-hundred swim lessons to the residents of Palm Beach County. The budget amendment recognizes the receipt of the \$5,000 donation and provides budget for the additional swim lesson expenditures fiscal year 2014. Countywide (PFK)
Background and Policy Issues: The DPC program was relocated to Palm Beach County Fire Rescue in October 2000. The primary funding sources for this program is FY2014 are a transfer from the County's general fund in the amount of \$150,000 and \$50,000 through an agreement with the Children's Services Council of Palm Beach County. The number of swim lessons offered each year is limited to the DPC program fund balance, donations and grant awards received each year. The DPC has received the same level of funding from the County's general fund since fiscal year 2007. A operational expenses increase, the fund balance decreases limiting the number of lessons the program can offer. This donation will allow the DPC program to offer one hundred additional swim lessons to the residents of Palm Beach County. The budge amendment will establish the budget for use of the donated funds in the current fiscal year.
