I. <u>EXECUTIVE BRIEF</u>

Motion and Title: Staff recommends motion to: A) Receive and File a Grant Modification #3 dated June 24, 2014, with the Office of National Drug Control Policy to provide an additional \$45,000 in reimbursable funding, for the Palm Beach Narcotics Task Force; and B) **Approve** a budget amendment of \$45,000 in the Sheriff's Grant Fund.

Summary: On April 2, 2013, the Board of County Commissioners (BOCC) accepted an award from the Office of National Drug Control Policy to provide \$50,403 in reimbursable funding for overtime and other expenses associated with the Palm Beach Narcotics Task Force (R-2013-0394). On December 17, 2013, the Board of County Commissioners (BOCC) accepted two grant modifications which provided a total of \$96,972 in additional reimbursable funding for overtime and other expenses associated with the Palm Beach Narcotics Task Force (R-2013-1853 and R-2013-1854). This third modification will provide an additional \$45,000 in reimbursable funding to offset equipment costs associated with the Palm Beach Narcotics Task Force. There is no match requirement associated with this award. No additional positions are needed and no additional County funds are required. Countywide (PGE)

Background and Justification: The HIDTA mission is to reduce drug availability by creating and supporting intelligence-driven task forces aimed at eliminating or reducing domestic drug trafficking and its harmful consequences through enhancement and coordination of drug trafficking control efforts among federal, state and local law enforcement agencies. The Catalog of Federal Domestic Assistance (CFDA) number is 95.001 and the contract number is G13MI0011A.
