



Motion and Title: Staff recommends motion to: **A) Accept** on behalf of the Palm Beach County Sheriff's Office, a High Intensity Drug Trafficking Area (HIDTA) Program grant in the amount of \$50,403, for the Palm Beach Narcotics Task Force, for the period of January 1, 2013 through December 31, 2014; **B) Approve** a budget amendment of \$50,403 in the Sheriff's Grant Fund.


Summary: On January 31, 2013, the Palm Beach County Sheriff's Office (PBSO) received an award from the Office of National Drug Control Policy. The funds will be used for overtime reimbursement and other expenses associated with the Palm Beach Narcotics Task Force. There is no match requirement associated with this award. No additional positions are needed and no additional County funds are required. Countywide (PGE)


Background and Justification: The HIDTA mission is to reduce drug availability by creating and supporting intelligence-driven task forces aimed at eliminating or reducing domestic drug trafficking and its harmful consequences through enhancement and coordination of drug trafficking control efforts among federal, state and local law enforcement agencies. The Catalog of Federal Domestic Assistance (CFDA) number is 95.001 and the contract number is G13MI0011A.




I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to: **A) Receive and File** a Grant Modification dated May 31, 2013, with the Office of National Drug Control Policy to provide an additional \$47,789, in reimbursable funding, for the Palm Beach Narcotics Task Force; and **B) Receive and File** a Grant Modification dated October 17, 2013, with the Office of National Drug Control Policy to provide an additional \$49,183, in reimbursable funding, for the Palm Beach Narcotics Task Force; and **C) Approve** a budget amendment of \$96,972 in the Sheriff's Grant Fund.

Summary: On April 2, 2013, the Board of County Commissioners (BOCC) accepted an award from the Office of National Drug Control Policy to provide \$50,403 in reimbursable funding for overtime and other expenses associated with the Palm Beach Narcotics Task Force (R-2013-0394). On May 31, 2013, the Office of National Drug Control Policy provided a supplemental award in the amount of \$47,789, in reimbursable funding, for overtime and other expenses associated with the Palm Beach County Narcotics Task Force. On October 17, 2013, the Office of National Drug Control Policy provided an additional supplemental award in the amount of \$49,183, in reimbursable funding, for overtime and other expenses associated with the Palm Beach County Narcotics Task Force. The two supplemental awards, totaling \$96,972, will provide additional funding to offset the costs associated with the Palm Beach Narcotics Task Force. There is no match requirement associated with this award. No additional positions are needed and no additional County funds are required. Countywide (PGE)
