I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Payment to the Florida Association of Counties, Inc. in the amount of \$2,500, and any subsequent invoice for a cumulative total not to exceed \$5,000, for Palm Beach County's share of costs and fees associated with the Department of Juvenile Justice Administrative Rule Challenge.

Summary: In response to the request for counties to participate in the litigation, the County Attorney recommended that Palm Beach County join and expend up to \$5,000. Receiving no objection, Palm Beach County was named along with the Florida Association of Counties (FAC) and 22 other counties as a plaintiff in the subject action. <u>Countywide</u> (DMN)

Background and Justification: FAC hired the law firm of Nabors, Giblin & Nickerson to represent FAC and 23 individual counties in administrative proceedings on the new proposed rules governing the counties' cost share of pre-disposition juvenile secured detention and the rule challenge flowing from those rules. This item requests approval of the payment to FAC of the invoice attached and payment of any subsequent invoices for a cumulative total not to exceed \$5,000.

The attached invoice is for your county to assist in the costs and fees associated with the Department of Juvenile Justice Rule Challenge that was filed on June 16, 2014 by the Florida Association of Counties and 23 individual counties. The amount on the attached invoice is the contribution for the administrative proceeding only. Any appeal taken by the counties or the Department from an administrative decision will result in additional contributions.

No medium sized county will be asked to pay more than \$3,000, from this point all the way through the Florida Supreme Court and no large, urban county will be asked to pay more than \$5,000. Accordingly, for the participating counties, if the county chooses to continue participate in any appeal from the administrative challenge, a subsequent invoice will be sent, at \$2,000 for medium sized counties and \$2,500 for large urban counties.

The Florida Association of Counties has hired the firm of Nabors, Giblin & Nickerson to represent FAC and the counties in the administrative proceedings on the new proposed administrative rules governing the counties' cost share of pre-disposition juvenile secured detention and the rule challenge flowing from those rules.
