I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: a Contract with All Webbs Enterprises, Inc. in the amount of \$105,250 for Mechanical Integrity Testing of Deep Injection Wells at Western Region Wastewater Treatment Plant and Western Region North Wastewater Treatment Plant.

Summary: In accordance with County PPM CW-0-051, all delegated contracts/agreements/grants/ procurement items must be submitted by the initiating Department as a receive and file agenda item. The document has been fully executed on behalf of the Board of County Commissioners (Board) by the County Administrator/Director/Deputy Director of the Water Utilities Department in accordance with Resolutions R93-1619, R96-0228, and R2003-0539 and are now being submitted to the Board to receive and file. (WUD Project No. 14-055) (District 6) (JM) **Original documents can be viewed in Minutes.**

Background and Justification: The Board of County Commissioners delegated the authority to execute various types of Standard Development Agreements, and related documents including Standard Indemnity Agreements to the Department Director including potable water and wastewater agreements (R93-1619); reclaimed water agreements (R96-0228); and additional conditions for potable water, wastewater, and reclaimed water agreements (R2003-0539). On July 25, 2014, the Director of the Water Utilities Department approved a contract with All Webbs Enterprises, Inc. in the amount of \$105,250 to provide all materials, labor, supervision, equipment, supplies, fees, expertise, and services necessary for the Mechanical Integrity Testing of Deep Injection Wells at Western Region Wastewater Treatment Plant and Western Region North Wastewater Treatment Plant. The Small Business Enterprise (SBE) participation goal established by the SBE Ordinance (R2022-0064) is 15% overall. The contract with All Webbs Enterprises, Inc. provides for SBE participation of 100% overall. All Webbs Enterprises, Inc. is a Palm Beach County company. This project is included in the FY14-15 Capital Improvement plan adopted by the Board of County Commissioners.

The Contract has been executed on behalf of the Board by the County Administrator/ Director/Deputy Director of the Water Utilities Department in accordance with the authority delegated by the Board, and are now being submitted to the Board to receive and file.
