The County has expended or encumbered \$233,378.72 (\$22,227/month) during the previous ten and one half (10.5) months of the current twelve (12) month term contract. The County has expended or encumbered \$907,347 (\$90,735/month) during the previous ten (10) months of the current twelve (12) month term contract. Fire Rescue Department has been directed by the BCC to retain a separate contract with a Personal Injury Protection (PIP) attorney. Fire Rescue Department has decided to have a separate contract for the electronic Patient Care Reporting (ePCR). To allow for sufficient time to coordinate with the County Attorney's Office and have the three (3) contracts in place, the Fire Rescue Department has requested a six (6) month extension to the existing contract. Based upon historical usage and an anticipated increase in transportation collections due to an anticipated increase of the emergency transport fee, \$31,722,703 in revenue is anticipated to be generated during this eighteen (18) month term. Of this amount, the contractor will be paid five point five percent (5.5%) of the non Medicaid gross monthly collections and point forty-nine percent (.49%) of the non Medicaid net monthly collections (for use of TripTix Software), which is estimated to be a total of \$1,871,000. This term contract has no renewal periods. Awardee is located outside Palm Beach county in the City of Fort Lauderdale, Florida. This contract was established by a competitive RFP process that allowed up to ten (10) points for SBE participation. No certified SBE participation was offered by the recommended awardee.
