FIRST AMENDMENT TO INDEPENDENT CONTRACTOR AGREEMENT BETWEEN PALM BEACH COUNTY AND CAROLINE KAROLINKO

WITNESSETH:

WHEREAS, on September 27, 2013, COUNTY and CONTRACTOR entered into an Agreement (R2013-1585) for the provision of a US synchronized swimming program at Aqua Crest Pool, hereinafter referred to as the "Agreement"; and

WHEREAS, under the Agreement the COUNTY is to provide funding in an amount not to exceed Twenty Five Thousand Dollars (\$25,000) for all services and materials for the US synchronized swimming coach's services, hereinafter referred to as the "Program"; and

WHEREAS, CONTRACTOR's fee is the sum of 80% of the paid enrollment fees for the Program; and

WHEREAS, paid enrollment fees are projected to exceeded Thirty One Thousand Two Hundred Fifty dollars (\$31,250) for the Agreement period; and

WHEREAS, the total Agreement amount required to be paid to CONTRACTOR needs to be increased by Ten Thousand dollars (\$10,000); and

WHEREAS, the Program benefits all citizens of Palm Beach County.

WHEREAS, both parties desire to amend the Agreement.

NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein, COUNTY and CONTRACTOR hereby agree as follows:

- 1. Section 3.a. of the Agreement is hereby deleted in its entirety and replaced with the following: "The total amount payable by COUNTY under this Agreement for the services to be performed hereunder is not to exceed Thirty Five Thousand dollars (\$35,000)."
- 2. Except as provided herein, each and every other term of the Agreement shall remain in full force and effect and the Agreement is reaffirmed as modified herein.
