### A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA ENDORSING PLANNED IMPROVEMENTS TO THE AGRIPLEX COMPLEX AT THE SOUTH FLORIDA FAIRGROUNDS.

WHEREAS, the South Florida Fair and Palm Beach County Expositions, Inc. ("Fair") is a nonprofit fair association organized and existing pursuant to Chapter 616, Florida Statutes; and

WHEREAS, the Fair has served the citizens of Palm Beach County, the region and the state for many years; and

WHEREAS, the Fair has provided outstanding facilities at its 123 acre Fairgrounds located in central Palm Beach County for the purpose of offering a vast array of different events including, without limitation, trade shows, circuses, concerts and the annual South Florida Fair which is held the last two weeks in January each year; and

WHEREAS, the Fair has always been an excellent showcase for the agriculture efforts of Palm Beach County and a vehicle for agriculture promotion and education in the region and the state; and

WHEREAS, the Board of Trustees has adopted a Master Plan which shows among other things substantial renovations to the area on the Fairgrounds dedicated to agriculture promotion and education which area is known as the Agriplex; and

WHEREAS, the main building in the Agriplex is in need of a new roof, skylights, and an HVAC system (the "Projects"), and in order to fund those improvements, the Fair has applied for an Agricultural Education and Promotion Facility Grant through the Florida Department of Agriculture and Consumer Services; and

WHEREAS, Palm Beach County endorses the proposed improvement Projects at the Agriplex since it fulfills a vital public purpose:

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Palm Beach County, Florida, that Palm Beach County supports and endorses the Projects at the Agriplex as set forth above, and acknowledge that the Fair, the Agriplex, and the aforementioned projects serve and fulfill a vital public purpose in Palm Beach County.

**BE IT FURTHER RESOLVED** that the County Administrator, County Attorney and Clerk are hereby authorized and directed to prepare, review and execute any documentation in order to carry out the intent of this Resolution.

The provision of this Resolution shall be effective immediately upon adoption hereof.
