I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: a contract in the amount of \$409,529.84 with Bridge Design Associates, Inc. (BDA), for professional services for the Palmetto Park Road over Lake Worth Drainage District (LWDD) E-4 Canal (El Rio Canal) bridge replacement project (Project).

SUMMARY: Approval of this contract will provide the professional services necessary for the preparation of design plans and construction bid documents for the Project. The Small Business Enterprise (SBE) goal for the Project is 15%. BDA has proposed 49.19% SBE participation for the Project. BDA is a Palm Beach County company and is a certified SBE.

Background and Justification: On October 29, 2013, the Consultant's Competitive Negotiations Act Selection Committee selected BDA and, in accordance with PPM No. CW-O-048, the Board of County Commissioners (Board) was notified of the selection on October 29, 2013. Palm Beach County now desires BDA to provide the professional services necessary for the preparation of design plans and construction bid documents for the Project.
