

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, DESIGNATING AS RIGHT-OF-WAY A PARCEL OF LAND LOCATED IN UNINCORPORATED PALM BEACH COUNTY ON THE EAST SIDE AND ADJACENT TO 1<sup>ST</sup> STREET BETWEEN Q STREET AND R STREET IN BELLE GLADE, FLORIDA.

WHEREAS, Palm Beach County (County) acquired a parcel of land (County parcel) by Tax Deed in 2002 (ORB 13639, Pg. 0293) which is located on the east side of 1<sup>st</sup> Street, between Q Street and R Street, in unincorporated Belle Glade, Florida more particularly described in the Tax Deed attached hereto and made part hereof as Exhibit "A"; and

WHEREAS, the County maintains this section of 1<sup>st</sup> Street Roadway; and

WHEREAS, the County parcel cuts off legal access to the two lots lying directly to the east of the County parcel; and

WHEREAS, County staff has reviewed the request for designation of the County parcel as right-of-way and recommends approval;

WHEREAS, the Board of County Commissioners has agreed to designate the County parcel as right-of-way and finds that the designation is in the best interest of the citizens and residents of the County.

Commissioners of Palm Beach County that:


