I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: contracts with Radise International, L.C. (Radise), Dunkelberger Engineering & Testing, Inc. (DET) and Professional Service Industries, Inc. (PSI), to provide the necessary professional services for construction materials testing, geotechnical engineering and inspection projects on a task order basis, for Palm Beach County (County) projects, as required.

SUMMARY: Approval of these contracts will provide the necessary professional services for construction materials testing, geotechnical engineering and inspections throughout the County for all user departments for an initial period of one year. At the option of the County, these contracts may be renewed annually for a period of one year, with a maximum of two renewals. The Small Business Enterprise (SBE) goal for each contract is 15%. The SBE participation committed for the contract by Radise is 95%, by DET is 35% and by PSI is 30%. Radise is a certified SBE company. Radise, DET and PSI are all Palm Beach County companies.

Countywide (MRE)

Background and Justification: On August 13, 2014, the Consultant's Competitive Negotiations Act Selection Committee selected Radise, DET and PSI and, in accordance with PPM No. CW-O-048, the Board of County Commissioners (Board) was notified of the selection on August 14, 2014. The County now desires Radise, DET and PSI to provide the necessary professional services on a task order basis.

After reviewing the attached contracts and finding them in proper order, staff recommends the Board's approval. Approval will maintain the continuous process of professional services required by the County.
