I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to adopt: a resolution to abandon any public interest in that certain portion of the 80 foot right-of-way dedication for Old Fairgrounds Road, from Southern Boulevard to approximately 800 feet north, being a parcel of land for road right-of-way purposes lying in Tracts 13, 18 and 19, Block 8 of Palm Beach Farms Company Plat No. 3, as recorded in Plat Book 2, Pages 45-54, Public Records of Palm Beach County, Florida, also being a portion of the lands described in Official Record Book 2749, Page 1880 of said Public Records.

SUMMARY: Adoption of this Resolution will allow Palm Beach County (County) to vacate its interest in that certain portion of 80 foot right-of-way for Old Fairgrounds Road from Southern Boulevard north approximately 800 feet that is in excess of County right-of-way requirements. The petition site is located on the north side of Southern Boulevard between Sansburys Way and State Road 7.

District 2 (MRE)

Background and Policy Issues: This application is being sponsored and processed by the County Engineer to release the County's interest in this excess right-of-way.

Reviewers and utilities service providers have no objection to the vacation.

Privilege Fee Statement: In accordance with the exemption in the County Code Chapter 22, Article III, Road Abandonment and Plat Vacation (Ordinance No. 2002-034), governmental agencies are exempt from the privilege fee.



OF RESOLUTION OF THE BOARD COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, ABANDON ANY PUBLIC INTEREST IN THAT TO CERTAIN PORTION OF THE 80 FOOT RIGHT-OF-WAY DEDICATION FOR OLD FAIRGROUNDS ROAD, FROM SOUTHERN BOULEVARD TO APPROXIMATELY 800 FEET NORTH, BEING A PARCEL OF LAND FOR ROAD **RIGHT-OF-WAY PURPOSES LYING IN TRACTS 13, 18** AND 19, BLOCK 8 OF PALM BEACH FARMS COMPANY PLAT NO. 3, AS RECORDED IN PLAT BOOK 2, PAGES 45-54, PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA, ALSO BEING A PORTION OF THE LANDS **DESCRIBED IN OFFICIAL RECORD BOOK 2749, PAGE 1880 OF SAID PUBLIC RECORDS.**

WHEREAS, the Board of County Commissioners (Board) of Palm Beach County, Florida (County), pursuant to authority in Section 336.09, Florida Statutes, and as provided in the County Code Chapter 22. Article III, Road Abandonment and Plat Vacation (Ordinance No. 2002-034), known as the County Right-of-Way Abandonment and Plat Vacation Ordinance, and the petition of the County Engineer, called a public hearing to be held in the County Commissioners' Chambers, at the Governmental Office Complex, West Palm Beach, Florida, on December 2, 2014, to consider and determine whether or not Palm Beach County would vacate, abandon, discontinue and close, renounce and disclaim any right or interest of the public in and for that portion of Old Fairgrounds Road as set forth on the sketch and legal description in Exhibit A attached hereto and incorporated herein by reference; and

WHEREAS, in accordance with and as provided in the County Code Chapter 22. Article III, Road Abandonment and Plat Vacation (Ordinance No. 2002-034), notice of the holding of such meeting was duly published in the Palm Beach Post on November 16, 2014; and

WHEREAS, this Board held said hearing as advertised and determined that such action will not materially interfere with the County Road System and will not deprive any person of a reasonable means of ingress and egress from at least one County, State or Federal highway.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY

- 1. The foregoing recitals are hereby reaffirmed and ratified.
- 2. The right-of-way is hereby abandoned and closed as public right-of-way and this Board does hereby renounce and disclaim any right or interest of the public in and to the right-of-way, more fully described in the legal description and sketch attached hereto as Exhibit A and made a part hereof.
- Notice of the adoption of this Resolution shall be published once in the Palm Beach Post within thirty (30) days of the date of adoption of this Resolution in accordance with Section 336.10, Florida Statutes and the County Code Chapter 22. Article III.




