An increase to the contract in the amount of \$144,210 is being requested for the following new or unanticipated County needs: Palm Tran Connection (\$70,000) requires additional temporary employees to support the upcoming transition to a new paratransit vendor; Public Safety (\$200) requires temporary clerical services; and \$74,010 is required for clerical temporary personnel services through contract expiration for all County Departments. This is a total of \$144,210 over the previously authorized amount of \$721,050 inclusive of the Purchasing Director's ten percent (10%) authority. This term contract has two (2) twelve (12) month renewal periods remaining. Two (2) Awardees are located in Palm Beach County and two (2) Awardees are located outside Palm Beach County in the cities of Sunrise and Miami, Florida. One (1) Vendor, A & Associates, Inc., is no longer an SBE.
