

**SECOND AMENDMENT TO THE
ANNUAL ASPHALT MILLING AND RESURFACING
CONTRACT NO. 2013052
DATED MARCH 12, 2013, BY AND BETWEEN
COMMUNITY ASPHALT CORP.,
AND PALM BEACH COUNTY**

THIS SECOND AMENDMENT to the Annual Asphalt Milling and Resurfacing Contract dated March 12, 2013, (R2013-0235), hereinafter "CONTRACT" by and between Community Asphalt Corp., hereinafter "CONTRACTOR" and the Board of County Commissioners of Palm Beach County, a political subdivision of the state of Florida, hereinafter, "COUNTY".

WITNESSETH

WHEREAS, on March 12, 2013, the CONTRACTOR and COUNTY entered into an Annual Asphalt Milling and Resurfacing Contract for milling and disposal of existing asphalt pavement, maintenance of traffic, cleaning of surfaces for finish applications, and furnishing, hauling, and placement of specified asphalt courses throughout Palm Beach County; and

WHEREAS, the COUNTY wishes to increase the amount of the CONTRACT; and

WHEREAS, by this amendment, the CONTRACTOR and the COUNTY mutually agree to amend the CONTRACT.

NOW, THEREFORE, in consideration of the mutual covenants, promises, and agreements herein contained, the parties agree as follows:

1. The above recitations are true and correct and incorporated herein.
2. The CONTRACT, dated March 12, 2013, between the CONTRACTOR and the COUNTY is hereby amended as follows:
 - A) The Contract (Page C-1) is amended to increase the amount of the Contract to \$14,110,000.
3. The Contract amount was previously increased via the First Amendment dated September 9, 2014 (R2014-1260 & R2014-1261) and increased the amount of the Contract to \$12,110,000.
4. It is the intent of the parties hereto that this Amendment shall not become binding until the date executed by the COUNTY.
5. All other provisions of the Annual Asphalt Milling and Resurfacing Contract dated March 12, 2013, shall remain in full force and effect.

5. All other provisions of the Annual Asphalt Milling and Resurfacing Contract dated March 12, 2013, shall remain in full force and effect.




