FIRST AMENDMENT TO INDEPENDENT CONTRACTOR AGREEMENT BETWEEN PALM BEACH COUNTY AND DEREK JONES

WITNESSETH:

WHEREAS, on December 31, 2014, COUNTY and CONTRACTOR entered into an Agreement (R2015-0214) for the provision of a US Diving program at North County Aquatic Complex, hereinafter referred to as the "Agreement"; and

WHEREAS, under the Agreement the COUNTY is to provide funding in an amount not to exceed Fifty Thousand Dollars (\$50,000) for all services and materials for the US Diving coach's services, hereinafter referred to as the "Program"; and

WHEREAS, CONTRACTOR's fee is the sum of 80% of the paid enrollment fees for the Program; and

WHEREAS, CONTRACTOR would like to increase the total time for some program activities, and increase the maximum participant fee from \$155 per month to \$200 per month; and

WHEREAS, the Program benefits all citizens of Palm Beach County.

WHEREAS, both parties desire to amend the Agreement.

NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein, COUNTY and CONTRACTOR hereby agree as follows:

- 1. The first sentence of Section 2. of the Agreement is hereby deleted in its entirety and replaced with the following: "The fee charged to participate in this activity is \$60.00-\$200.00 per month."
- 2. Except as provided herein, each and every other term of the Agreement shall remain in full force and effect and the Agreement is reaffirmed as modified herein.
