I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Supplemental Agreement No. 1 (Supplement) in the amount of \$270,564.92 with Kimley-Horn and Associates, Inc. (KHA), for professional services for the preparation of design plans and construction bid documents for West Atlantic Avenue and Florida's Turnpike Intersection Improvements project (Project).

SUMMARY: Approval of this Supplement will provide for the preparation of design plans and construction bid documents for the Project. This Supplement is under the Work Task Order dated October 16, 2013 under the Annual Intersection Improvement Agreement (Annual) dated May 17, 2011 R2011-0704. KHA is a Palm Beach County company. The Small Business Enterprise (SBE) goal for the Annual is 15%. The SBE participation proposed for this Supplement by KHA is 16.4%.

District 5 (MRE)

Background and Justification: On May 17, 2011, the Board of County Commissioners (Board) approved the Annual R2011-0704 with KHA to provide professional services required for Palm Beach Countywide (County) Intersection Improvement projects. The Work Task Order dated October 16, 2013, prepared the study of alternatives for the addition of turn lanes for the Project. The County now desires KHA to prepare design plans and construction bid documents for the selected alternative for the Project as detailed in Exhibit "A" of the attached Supplement. The fee, as detailed in Exhibit "A" of the attached Supplement as just and reasonable compensation as follows:

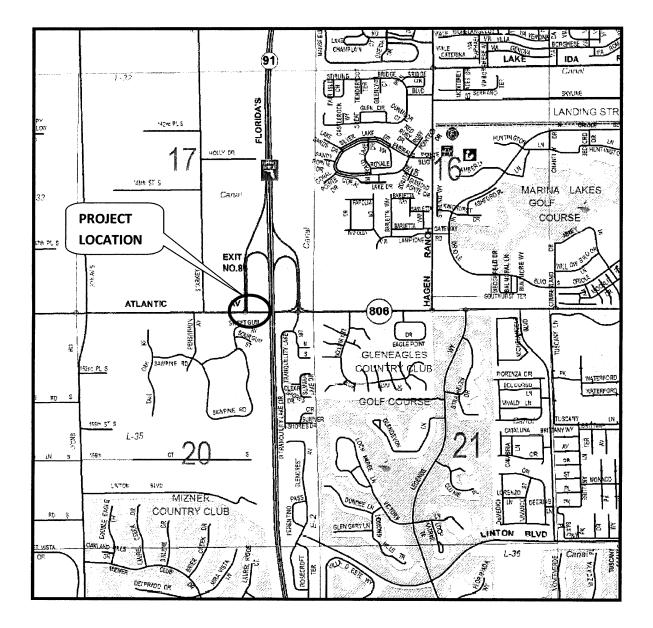
