## I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: Letter from S. Renée Narloch \& Associates, dated May 13, 2015, correcting County Administrator selection rankings for the official record.

Summary: On Tuesday, May 12, 2015, the Board of County Commissioners interviewed six candidates for the County Administrator position and selected Deputy County Administrator Verdenia Baker to succeed Mr. Weisman upon his retirement. After the results were announced at the end of the day, a recording and tabulation error was noticed. The search consultant, S. Renée Narloch misinterpreted the candidate rankings submitted by Commissioner Priscilla A. Taylor. The corrected rankings do not alter the final results. Background and Policy Issues: County Administrator Robert Weisman will retire from Palm Beach County government in August 2015. On September 9, 2014, the BCC entered into a contract with NP\&S Management, Inc. d/b/a S. Renée Narloch \& Associates to serve as the consultant for the executive search of a new County Administrator. On May 12, 2015, following day long interviews, the BCC selected Deputy County Administrator Verdenia Baker.

Ms. Verdenia Baker - 4 (formerly 3)
Ms. Shannon LaRocque - 2 (no change)
Mr. Tom Himler - 1 (no change)
Fortunately, the results are still clearly in favor of Ms. Verdenia Baker as the top candidate. We ask that you ensure the County's records are updated and reflective of this scoring adjustment.
