### I. EXECUTIVE BRIEF

**Motion and Title**: **Staff recommends motion to ratify:** Signature of the Mayor on the Florida Department of Education Project Application for the period July 1, 2015, through June 30, 2016, in an amount not to exceed \$278,268 for the Farmworker Career Development Program under Title I, Section 167 of the Workforce Innovation and Opportunity Act (WIOA).

**Summary**: The Farmworker Career Development Program is funded by the Florida Department of Education to provide academic education and vocational training to farm workers and their dependents to obtain permanent employment outside of farm work. The emergency signature process was utilized because there was not sufficient time to submit the application through the regular agenda process and meet the submission deadline of April 24, 2015. No County funds are required. (Farmworker Career Development Program) <u>Countywide</u> (HH)

**Background and Justification:** The Farmworker Career Development Program has been providing services to the farm worker population of Palm Beach Country for 37 years. The program is currently funded through the Florida Department of Education under Title I, Section 167 of the WIOA.
