On April 21, 2015, the Board of County Commissioners (BOCC) received and filed an agenda item increasing the grant award by \$124,470 (R-2015-0518). This modification will provide an additional \$31,902 in reimbursable funding to offset costs associated with the Palm Beach Narcotics Task Force.
