I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 6 to the Agreement (R-2010-1219) with the law firm of Bryant Miller Olive P.A. (“Attorney”), to provide bond counsel and related legal services for the \$19 Million Max Planck Grant Funding Bonds, Series 2015 (the “Bonds”).

This Amendment No. 6, dated _____, 2015, amends Agreement R-2010-1219 ("Agreement"), as amended by R-2012-0306, R-2012-1358, R-2013-0852, R-2014-0906, and R-2015-0030 by and between Palm Beach County ("County") and Bryant Miller Olive P.A. ("Attorney"), as follows:


