I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: exercise of the first option to extend the term of the Concessionaire Service Agreement (R2012-0892) dated June 19, 2012, with Kayak-King Watersports, Inc., for the continued operation of a water sports and recreational rental concession in Okeeheelee Park at an annual rate of \$6,897.85.

Summary: Kayak-King Watersports, Inc. has operated its concession in Okeeheelee Park since July 2012 under the current Concessionaire Service Agreement (R2012-0892). The initial term of the Agreement was for three (3) years ending on June 30, 2015, with two (2) extension options, each for a period of two (2) years. This option will extend the term of the Agreement for two (2) years, from July 1, 2015, through June 30, 2017. The annual rent for the first year of this two (2) year extension period increases two percent (2%) to \$6,897.85. The Board has no discretionary authority to deny the exercise of the option; however, the Board may terminate this Agreement upon ninety (90) days written notice. All other terms and conditions of the Concessionaire Service Agreement shall remain in full force and effect. Parks will continue to have administrative responsibility for this Agreement. (PREM) <u>District 2</u> (HJF)

Background and Justification: On June 19, 2012, the Board approved the Concessionaire Service Agreement which expires on June 30, 2015. The Agreement requires Kayak-King Watersports to request the term extension option between one hundred fifty (150) and ninety (90) days prior to the June 30, 2015, expiration date (between February 1, 2015, and April 2, 2015). Kayak-King Watersports submitted their request on April 1, 2015, as shown on Attachment #2. The exercise of this first option will extend the term of the Agreement for two (2) years until June 30, 2017. The annual rent will increase two percent (2%) on July 1, 2015, to \$6,897.85, and then another two percent (2%) on July 1, 2016, to \$7,035.81. The Parks and Recreation Department manages this Agreement and is satisfied with Kayak-King Watersports' performance. Florida Statutes Section 286.23 requires that a Disclosure of Beneficial Interest be obtained when a property held in a representative capacity is leased to the County, but does not require such Disclosure when the County leases property to a tenant. Since the Statute does not require the Disclosure and as this is an exercise of an option to a Concessionaire Service Agreement which was previously approved by the Board, Staff did not request a new Disclosure.


