**Summary:** The Westgate/Belvedere Homes Community Redevelopment Agency (Westgate CRA) Board consists of seven (7) At-Large members from the general public and local businesses within the CRA boundaries. Ordinance No. 89-6 requires that the Palm Beach County Board of County Commissioners (BCC) appoint the Westgate CRA Board Members. After duly advertising, the Westgate CRA held its Annual Meeting on May 11, 2015 to re-appoint a candidate to fill Seat 5. Ruth Haggerty, a resident, has expressed a willingness to remain on the CRA Board in Seat 5. The Commissioners were notified of the vacancy by the Westgate CRA on June 17, 2015. Districts a + 1 (LB)

**Background and Justification:** Westgate CRA was created by the Board of County Commissioners pursuant to Ordinance No. 89-6, adopted in May, 1989 and amended by Ordinance No. 91-50, adopted in March, 1991. The Westgate CRA By-laws provide for board members and the public to nominate prospective candidates for the Westgate Belvedere Homes CRA Board and to forward the nominations to the Palm Beach County Board of County Commissioners for appointment. The Westgate/Belvedere Homes CRA Board consists of seven (7) members seats, with a diversity count of Male: 4; Female: 3; and White: 6 and Black: 1.

Section 1. AUTHORITY FOR ENACTMENT. This ordinance is enacted pursuant to the Community 2 Redevelopment Act of 1969, as amended, Chapter 69-305, Laws of Florids. 3 Section 2. CREATION OF THE WESTGATE/BELVEDERE HOMES COMMUNITY 4 5 REDEVELOPMENT AGENCY There is hereby created a public body corporate and politic to 6 he known as the Westgate/Belvedera Homas Community Radevelopment Agency, 7 hareinafter referred to as the "Agency." 8 9 Section 3. MEMBERSHIP 10 3.01. The agency shall consist of seven (7) commissioners appointed by the Board of County Commissioners. Any person may be 11 appointed as a commissioner if he or she resides or is engaged in 12 business, which shall mean owning a business, practicing a profession, or 13 performing a service for compensation, or serving as an officer or 14 director of a corporation or other business entity so engaged, within the . 15 area of operation of the agency, which shall be coterminous with the area 16 17 of operation of the county. 3.02. Terms of office of the commissioners shall be for 4 years 15 except that three of the members first sppointed shall be designated to 19 serve terms of 1, 2 and 3 years, respectively, from the date of their 20 appointments, and four (4) members shall be designated to serve for terms 21 of 4 years from the date of their appointments. A vacancy occurring 22 during a term shall be filled for the unexpired term. A certificate of 23

the appointment or reappointment of any commissioner shall be filed with the clerk of the county, and such certificate shall be conclusive evidence of the due and proper appointment of such commissioner.

3.03. A commissioner shall receive no compansation for his services, but shall be entitled to the necessary expenses, including traveling expenses, incurred in the discharge of his duties, subject to prior approval by the Board of County Commissioners.

31 <u>3.04</u>. The powers of a community redevelopment sgency shall be a exercised by the commissioners thereof. A majority of the commissioners shall constitute a quorum for the purpose of conducting business and a sercising the powers of the agency and for all other purposes. Action may be taken by the agency upon a vote of a majority of the commissioners present, unless in any case the bylaws shall require a larger number.
