I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Contract with AKA Services, Inc. for the SR 15 (Main Street) and Gator Boulevard 16" and 12" Water Main Extension Project in the City of Belle Glade in the amount of \$2,149,199.

Summary: On March 11, 2015, six (6) bids were received for the SR 15 (Main Street) and Gator Boulevard 16" and 12" Water Main Extension Project (Project). The Project provides for improvements to the water system infrastructure along State Road 15 and Gator Boulevard in the City of Belle Glade. These improvements are part of the continued restoration and repair of water infrastructure in the Glades Region and will result in improved water quality and fire protection to the residents and businesses of the City of Belle Glade. AKA Services, Inc. was the lowest responsive, responsible bidder in the amount of \$2,149,199. The Small Business Enterprise (SBE) participation goal established by the SBE Ordinance (R2002-0064) is 15% overall. The contract with AKA Services, Inc. provides for SBE participation of 15.5% overall. AKA Services, Inc. is a Palm Beach County company. This project is included in the FY15 Capital Improvement plan adopted by the Board of County Commissioners (BCC). (WUD Project No. 13-052) <u>District 6</u> (MRE)

Background and Justification: On January 15, 2013, (R2013-0094) the BCC approved the First Amendment to the Interlocal Agreement by and among Palm Beach County and the Cities of Belle Glade, Pahokee and South Bay (R2009-1033 thru R2009-1035). As a result of the Amendment, the County committed to make a capital contribution of \$17,500,000 to repair and replace parts of the utility system in the City of Belle Glade in the first five (5) years following the transfer date (March 31, 2013). The Water Utilities Department has determined that the existing water main pipes along State Road 15 and Gator Boulevard are in need of replacement based on the number of main breaks, leaks, age and pipe capacity, as well as the need for fire protection improvements.




WUD No 13-052 LOCATION MAP

The bid opening for the above referenced project was held on Wednesday, March 11, 2015. Bids were received from six (6) contractors. A summary of the results of the bidders' total base bid price is as follows:

The engineer's recommendation is to award to AKA Services, Inc. as the lowest responsive bidder.

The engineer's opinion of probable construction cost was \$2,400,000. An evaluation of the low bid is as follows:

1. The Bid Form provided in the Contract Documents was properly executed.

- 2. Bid security equal to 5% of the total base bid was enclosed on the form provided in the Contract Documents.
- 3. The contractor holds a valid general contractor's and occupational license. AKA Services, Inc. has Local Preference and has submitted the required documentation.
- 4. The lowest responsive bidder acknowledged the one (1) addendum.
- 5. SBE-M/WBE Schedules #1 and #2 provided in the Contract Documents were properly filled out. The low bidder has met the 15% SBE goal established under the SBE Ordinance. (A copy of the Office of Small Business Assistance SBE-M/WBE Compliance Review is attached.)

Water Utilities staff when evaluating the bid carefully considered the overall experience, qualifications and resources of the low bidder. Contract award to the low responsive bidder, AKA Services, Inc. in the amount of \$2,149,199.00 is recommended.

A copy of this notice has been posted at the bid opening location and will be left there for a minimum of five (5) business days.
